# PREVENTION OF CRUELTY AND EXPOSURE TO MORAL AND PHYSICAL DANGER

# Offences

# 1 Cruelty to persons under sixteen.

- (1) If any person who has attained the age of sixteen years and [<sup>FI</sup>has responsibility for] any child or young person under that age, wilfully assaults, ill-treats, neglects, abandons, or exposes him, or causes or procures him to be assaulted, ill-treated, neglected, abandoned, or exposed, in a manner likely to cause him unnecessary suffering or injury to health (including injury to or loss of sight, or hearing, or limb, or organ of the body, and any mental derangement), that person shall be guilty of a misdemeanor, and shall be liable—
  - (a) on conviction on indictment, to a fine . . . <sup>F2</sup> or alternatively, . . . <sup>F3</sup>, or in addition thereto, to imprisonment for any term not exceeding [<sup>F4</sup>ten] years;
  - (b) on summary conviction, to a fine not exceeding [<sup>F5</sup>£400] pounds, or alternatively,  $\ldots$  <sup>F3</sup>, or in addition thereto, to imprisonment for any term not exceeding six months.
- (2) For the purposes of this section—
  - (a) a parent or other person legally liable to maintain a child or young person [<sup>F6</sup>, or the legal guardian of a child or young person,] shall be deemed to have neglected him in a manner likely to cause injury to his health if he has failed to provide adequate food, clothing, medical aid or lodging for him, or if, having been unable otherwise to provide such food, clothing, medical aid or lodging, he has failed to take steps to procure it to be provided under [<sup>F7</sup>the enactments applicable in that behalf];
  - (b) where it is proved that the death of an infant under three years of age was caused by suffocation (not being suffocation caused by disease or the presence of any foreign body in the throat or air passages of the infant) while the infant

was in bed with some other person who has attained the age of sixteen years, that other person shall, if he was, when he went to bed, under the influence of drink, be deemed to have neglected the infant in a manner likely to cause injury to its health.

- (3) A person may be convicted of an offence under this section—
  - (a) notwithstanding that actual suffering or injury to health, or the likelihood of actual suffering or injury to health, was obviated by the action of another person;
  - (b) notwithstanding the death of the child or young person in question.

# 3 Allowing persons under sixteen to be in brothels.

- (1) If any person having [<sup>F12</sup>responsibility for] a child or young person who has attained the age of four years and is under the age of sixteen years, allows that child or young person to reside in or to frequent a brothel, he shall be [<sup>F13</sup>liable on summary conviction to a fine not exceeding [<sup>F14</sup>level 2 on the standard scale]], or alternatively . . . <sup>F15</sup> or in addition thereto, to imprisonment for any term not exceeding six months.

## 4 Causing or allowing persons under sixteen to be used for begging.

- (1) If any person causes or procures any child or young person under the age of sixteen years or, having [<sup>F17</sup>responsibility for] such a child or young person, allows him to be in any street, premises, or place for the purpose of begging or receiving alms, or of inducing the giving of alms (whether or not there is any pretence of singing, playing, performing, offering anything for sale, or otherwise) he shall, on summary conviction, be liable to a fine not exceeding [<sup>F18</sup>level 2 on the standard scale], or alternatively, ... <sup>F19</sup> or in addition thereto, to imprisonment for any term not exceeding three months.
- (2) If a person having [<sup>F17</sup>responsibility for] a child or young person is charged with an offence under this section, and it is proved that the child or young person was in any street, premises, or place for any such purpose as aforesaid, and that the person charged allowed the child or young person to be in the street, premises, or place, he shall be presumed to have allowed him to be in the street, premises, or place for that purpose unless the contrary is proved.
- (3) If any person while singing, playing, performing or offering anything for sale in a street or public place has with him a child who has been lent or hired out to him, the child shall, for the purposes of this section, be deemed to be in that street or place for the purpose of inducing the giving of alms.

# 5 Giving intoxicating liquor to children under five.

If any person gives, or causes to be given, to any child under the age of five years any [ $^{F20}$  alcohol (within the meaning given by section 191 of the Licensing Act 2003, but disregarding subsection (1)(f) to (i) of that section)], except upon the order of a duly qualified medical practitioner, or in case of sickness, apprehended sickness, or other urgent cause, he shall, on summary conviction, be liable to a fine not exceeding [ $^{F21}$ level 1 on the standard scale].

# 7 Sale of tobacco, &c. to persons under [<sup>F23</sup>eighteen].

- (1) Any person who sells to a person [<sup>F24</sup>. . .] under the age of [<sup>F25</sup>eighteen] years any tobacco or cigarette papers, whether for his own use or not, shall be liable, [<sup>F26</sup>on summary conviction to a fine not exceeding level 4 on the standard scale.]
- <sup>F27</sup>[(1A) It shall be a defence for a person charged with an offence under subsection (1) above to prove that he took all reasonable precautions and exercised all due diligence to avoid the commission of the offence.]
  - (2) If on complaint to a [<sup>F28</sup>magistrates' court] it is proved to the satisfaction of the court that any automatic machine for the sale of tobacco kept on any premises [<sup>F29</sup>has been used by any person] under the age of [<sup>F25</sup>eighteen] years, the court [<sup>F30</sup>shall] order the owner of the machine, or the person on whose premises the machine is kept, to take such precautions to prevent the machine being so used as may be specified in the order or, if necessary, to remove the machine, within such time as may be specified in the order, and if any person against whom such an order has been made fails to comply therewith, he shall be liable, on summary conviction, [<sup>F31</sup>to a fine not exceeding level 4 on the standard scale.]
  - (3) It shall be the duty of a constable and of a park-keeper being in uniform to seize any tobacco or cigarette papers in the possession of any person apparently under the age of sixteen years whom he finds smoking in any street or public place, and any tobacco or cigarette papers so seized shall be disposed of, if seized by a constable, in such manner as the [<sup>F32</sup>local policing body] may direct, and if seized by a park-keeper, in such manner as the authority or person by whom he was appointed may direct.
  - (4) Nothing in this section shall make it an offence to sell tobacco or cigarette papers to, or shall authorise the seizure of tobacco or cigarette papers in the possession of, any person who is at the time employed by a manufacturer of or dealer in tobacco, either wholesale or retail, for the purposes of his business, or is a boy messenger in uniform in the employment of a messenger company and employed as such at the time.
  - (5) For the purposes of this section the expression "tobacco" includes cigarettes [<sup>F33</sup>any product containing tobacco and intended for oral or nasal use] and smoking mixtures intended as a substitute for tobacco, and the expression "cigarettes" includes cut tobacco rolled up in paper, tobacco leaf, or other material in such form as to be capable of immediate use for smoking.

# 11 *†*Exposing children under seven to risk of burning.

If any person who has attained the age of sixteen years, having [<sup>F37</sup>responsibility for] any child under the age of [<sup>F38</sup>twelve] years, allows the child to be in any room containing an open fire grate [<sup>F39</sup>or any heating appliance liable to cause injury to a person by contact therewith] not sufficiently protected to guard against the risk of his being burnt or scalded without taking reasonable precautions against that risk, and by reason thereof the child is killed or suffers serious injury, he shall on summary conviction be liable to a fine not exceeding [<sup>F40</sup>level 1 on the standard scale]:

Provided that neither this section, not any proceedings taken thereunder, shall affect any liability of any such person to be proceeded against by indictment for any indictable offence.

## 12 Failing to provide for safety of children at entertainments.

- (1) Where there is provided in any building an entertainment for children, or an entertainment at which the majority of the persons attending are children, then, if the number of children attending the entertainment exceeds one hundred, it shall be the duty of the person providing the entertainment to station and keep stationed wherever necessary a sufficient number of adult attendants, properly instructed as to their duties, to prevent more children or other persons being admitted to the building, or to any part thereof, than the building or part can properly accommodate, and to control the movement of the children and other persons admitted while entering and leaving the building or any part thereof, and to take all other reasonable precautions for the safety of the children.
- (2) Where the occupier of a building permits, for hire or reward, the building to be used for the purpose of an entertainment, he shall take all reasonable steps to secure the observance of the provisions of this section.
- (3) If any person on whom any obligation is imposed by this section fails to fulfil that obligation, he shall be liable, on summary conviction, to a fine not exceeding, in the

case of a first offence fifty pounds, and in the case of a second or subsequent offence one hundred pounds  $^{\rm F41}$  . . .

- (4) A constable may enter any building in which he has reason to believe that such an entertainment as aforesaid is being, or is about to be, provided, with a view to seeing whether the provisions of this section are carried into effect, and an officer authorised for the purpose by an authority by whom licences are granted under any of the enactments referred to in the last foregoing subsection shall have the like power of entering any building so licensed by that authority.
- (5) The institution of proceedings under this section shall—
  - [<sup>F42</sup>(a) in the case of a building in respect of which a premises licence authorising the provision of regulated entertainment has effect, be the duty of the relevant licensing authority;]
    - (b) in any other case, be the duty of the [ $^{F43}$ chief officer of police].

[<sup>F44</sup>(5A) For the purposes of this section—

- (b) "the relevant licensing authority", in relation to a building in respect of which a premises licence has effect, means the relevant licensing authority in relation to that building under section 12 of that Act.]

# 12A Restricted premises orders

- (1) This section applies where a person ("the offender") is convicted of a tobacco [<sup>F47</sup>or nicotine] offence ("the relevant offence").
- (2) The person who brought the proceedings for the relevant offence may by complaint to a magistrates' court apply for a restricted premises order to be made in respect of the premises in relation to which that offence was committed ("the relevant premises").
- (3) A restricted premises order is an order prohibiting the sale on the premises to which it relates of any tobacco [<sup>F48</sup> or cigarette papers][<sup>F48</sup>, cigarette papers or nicotine product] to any person.
- (4) The prohibition applies to sales whether made—
  - (a) by the offender or any other person, or
  - (b) by means of any machine kept on the premises or any other means.
- (5) The order has effect for the period specified in the order, but that period may not exceed one year.
- (6) The applicant must, after making reasonable enquiries, give notice of the application to every person appearing to the applicant to be a person affected by it.
- (7) The court may make the order if (and only if) it is satisfied that—
  - (a) on at least 2 occasions within the period of 2 years ending with the date on which the relevant offence was committed, the offender has committed other tobacco [<sup>F49</sup> or nicotine] offences in relation to the relevant premises, and
  - (b) the applicant has complied with subsection (6).
- (8) Persons affected by the application may make representations to the court as to why the order should not be made.
- (9) If—
  - (a) a person affected by an application for a restricted premises order was not given notice under subsection (6), and
  - (b) consequently the person had no opportunity to make representations to the court as to why the order should not be made,

the person may by complaint apply to the court for an order varying or discharging it.

- (10) On an application under subsection (9) the court may, after hearing—
  - (a) that person, and
  - (b) the applicant for the restricted premises order,

make such order varying or discharging the restricted premises order as it considers appropriate.

- (11) For the purposes of this section the persons affected by an application for a restricted premises order in respect of any premises are—
  - (a) the occupier of the premises, and
  - (b) any other person who has an interest in the premises.

## 12B Restricted sale orders

- (1) This section applies where a person ("the offender") is convicted of a tobacco [<sup>F50</sup>or nicotine] offence ("the relevant offence").
- (2) The person who brought the proceedings for the relevant offence may by complaint to a magistrates' court apply for a restricted sale order to be made in respect of the offender.
- (3) A restricted sale order is an order prohibiting the person to whom it relates—
  - (a) from selling any tobacco [<sup>F51</sup> or cigarette papers][<sup>F51</sup>, cigarette papers or nicotine products] to any person,
  - (b) from having any management functions in respect of any premises in so far as those functions relate to the sale on the premises of tobacco [<sup>F52</sup> or cigarette papers][<sup>F52</sup>, cigarette papers or nicotine products] to any person,
  - (c) from keeping any [<sup>F53</sup>cigarette] machine on any premises for the purpose of selling tobacco [<sup>F54</sup>or nicotine products] or permitting any [<sup>F53</sup>cigarette] machine to be kept on any premises by any other person for that purpose, and
  - (d) from having any management functions in respect of any premises in so far as those functions relate to any [<sup>F55</sup>cigarette] machine kept on the premises for the purpose of selling tobacco [<sup>F56</sup>or nicotine products].

# 12C Enforcement

- (1) If—

# 14 Mode of charging offences and limitation of time.

- (1) Where a person is charged with committing any of the offences mentioned in the First Schedule to this Act in respect of two or more children or young persons, the same information or summons may charge the offence in respect of all or any of them, but the person charged shall not, if he is summarily convicted, be liable to a separate penalty in respect of each child or young person except upon separate informations.

# 21 Penalties and legal proceedings in respect of general provisions as to employment.

(1) If a person is employed in contravention of any of the foregoing provisions of this Part of this Act, or of the provisions of any byelaw [<sup>F95</sup> or regulation] made thereunder, the employer and any person (other than the person employed) to whose act or default the contravention is attributable shall be liable on summary conviction to a fine not exceeding [<sup>F96</sup>twenty pounds][<sup>F97</sup>£50] or, in the case of a second or subsequent offence, not exceeding [<sup>F96</sup>fifty pounds][<sup>F98</sup>£100]:

# 24 Restrictions on training for performances of a dangerous nature.

# 26 Punishment of contraventions of last foregoing section and proceedings with respect thereto.

(1) If any person acts in contravention of the provisions of subsection (1) of the last foregoing section he shall be guilty of an offence under this section and be liable, on summary conviction, to a fine not exceeding [<sup>F129</sup>level 3 on the standard scale], or, alternatively, . . . <sup>F130</sup>or in addition thereto, to imprisonment for any term not exceeding three months:

# 37 Power to clear court while child or young person is giving evidence in certain cases.

# 41 Power to proceed with case in absence of child or young person.

Where in any proceedings with relation to any of the offences mentioned in the First Schedule to this Act, the court is satisfied that the attendance before the court of any child or young person in respect of whom the offence is alleged to have been committed is not essential to the just hearing of the case, the case may be proceeded with and determined in the absence of the child or young person.

# 42 Extension of power to take deposition of child or young person.

- (1) Where a justice of the peace is satisfied by the evidence of a duly qualified medical practitioner that the attendance before a court of any child or young person in respect of whom any of the offences mentioned in the First Schedule to this Act is alleged to have been committed would involve serious danger to his life or health, the justice may take in writing the deposition of the child or young person on oath, and shall thereupon subscribe the deposition and add thereto a statement of his reason for taking it and of the day when and place where it was taken, and of the names of the persons (if any) present at the taking thereof.
- (2) The justice taking any such deposition shall transmit it with his statement—
  - (a) if the deposition relates to an offence for which any accused person is already  $[^{F192}sent]$  for trial, to the proper officer of the court for the trial at which the accused person has been  $[^{F192}sent]$ ; and

# 43 Admission of deposition of child or young person in evidence.

Where, in any proceedings in respect of any of the offences mentioned in the First Schedule of this Act, the court is satisfied by the evidence of a duly qualified medical practitioner that the attendance before the court of any child or young person in respect of whom the offence is alleged to have been committed would involve serious danger to his life or health, any deposition of the child or young person taken under the <sup>M4</sup>Indictable Offences Act 1848, or this Part of this Act, shall be admissible in evidence either for or against the accused person without further proof thereof if it purports to be signed by the justice by or before whom it purports to be taken:

# Youth Courts

# [<sup>F197</sup>45 Constitution of Youth courts.

(1) Magistrates' courts-

- (a) constituted in accordance with this section or section 66 of the Courts Act 2003 (judges having powers of District Judges (Magistrates' Courts)), and
- (b) sitting for the purpose of—

# 46 Assignment of certain matters to [<sup>F202</sup>youth courts].

 Subject as hereinafter provided, no charge against a child or young person, and no application whereof the hearing is by rules made under this section assigned to [<sup>F202</sup>youth courts], shall be heard by a [<sup>F203</sup>magistrates' court] which is not a [<sup>F202</sup>youth court]:

Provided that-

- (a) a charge made jointly against a child or young person and a person who has attained [<sup>F204</sup>the age of eighteen] years shall be heard by a [<sup>F203</sup>magistrates' court] other than a [<sup>F202</sup>youth court]; and
- (b) where a child or young person is charged with an offence, the charge may be heard by a [<sup>F203</sup>magistrates' court] which is not a [<sup>F202</sup>youth court] if a person who has attained [<sup>F204</sup>the age of eighteen] years is charged at the same time with aiding, abetting, causing, procuring, allowing or permitting that offence; and
- (c) where, in the course of any proceedings before any [<sup>F203</sup>magistrates' court] other than a [<sup>F202</sup>youth court], it appears that the person to whom the proceedings relate is a child or young person, nothing in this subsection shall be construed as preventing the court, if it thinks fit so to do, from proceeding with the hearing and determination of those proceedings.

    - (a) that it is appropriate to do so for the purpose of avoiding injustice to the child or young person; or
    - (b) that, as respects a child or young person to whom this paragraph applies who is unlawfully at large, it is necessary to dispense with those requirements for the purpose of apprehending him and bringing him before a court or returning him to the place in which he was in custody.
  - (6) Paragraph (b) of subsection (5) above applies to any child or young person who is charged with or has been convicted of—
    - (a) a violent offence,
    - (b) a sexual offence, or

(c) an offence punishable in the case of a person aged 21 or over with imprisonment for fourteen years or more.

(7) The court shall not exercise its power under subsection (5)(b) above—

- (a) except in pursuance of an application by or on behalf of the Director of Public Prosecutions; and
- (b) unless notice of the application has been given by the Director of Public Prosecutions to any legal representative of the child or young person.
- (8) The court's power under subsection [<sup>F234</sup>(4A) or] (5) above may be exercised by a single justice.

[F235(9) If a publication includes any matter in contravention of subsection (1) above, the following persons shall be guilty of an offence and liable on summary conviction to a fine not exceeding level 5 on the standard scale—

  - (b) to be attributable to any neglect on the part of,

an officer, the officer as well as the body corporate is guilty of the offence and liable to be proceeded against and punished accordingly.

- (9C) In subsection (9B) above "officer" means a director, manager, secretary or other similar officer of the body, or a person purporting to act in any such capacity.
- (9D) If the affairs of a body corporate are managed by its members, "director" in subsection (9C) above means a member of that body.
- (9E) Where an offence under subsection (9) above is committed by a Scottish partnership and is proved to have been committed with the consent or connivance of a partner, he as well as the partnership shall be guilty of the offence and shall be liable to be proceeded against and punished accordingly.]
- (10) In any proceedings under [<sup>F236</sup>Schedule 2 to the Criminal Justice and Immigration Act 2008 (proceedings for breach, revocation or amendment of youth rehabilitation orders)] before a magistrates' court other than a youth court or on appeal from such a court it shall be the duty of the magistrates' court or the appellate court to announce in the course of the proceedings that this section applies to the proceedings; and if the court fails to do so this section shall not apply to the proceedings.

# 58 Power of Secretary of State to send certain juvenile offenders to approved schools.

The Secretary of State may by order direct that-

- (a) a person who is under the age of eighteen years and is undergoing detention in a Borstal institution; or

# 99 Presumption and determination of age.

- (1) Where a person, whether charged with an offence or not, is brought before any court otherwise than for the purpose of giving evidence, and it appears to the court that he is a child or young person, the court shall make due inquiry as to the age of that person, and for that purpose shall take such evidence as may be forthcoming at the hearing of the case, but an order or judgment of the court shall not be invalidated by any subsequent proof that the age of that person has not been correctly stated to the court, and the age presumed or declared by the court to be the age of the person so brought before it shall, for the purposes of this Act, be deemed to be the true age of that person, and, where it appears to the court that the person so brought before it has attained [<sup>F289</sup>the age of eighteen] years, that person shall for the purposes of this Act be deemed not to be a child or young person.
- (2) Where in any charge or indictment for any offence under this Act or any of the offences mentioned in the First Schedule to this Act [<sup>F290</sup>except as provided in that Schedule], it is alleged that the person by or in respect of whom the offence was committed was a child or young person or was under or had attained any specified age, and he appears to the court to have been at the date of the commission of the alleged offence a child or young person, or to have been under or to have attained the specified age, as the case may be, he shall for the purposes of this Act be presumed at that date to have been a child or young person or to have been under or to have attained that age, as the case may be, unless the contrary is proved.
- (3) Where, in any charge or indictment for any offence under this Act or any of the offences mentioned in the First Schedule to this Act, it is alleged that the person in respect of whom the offence was committed was a child or was a young person, it shall not be a defence to prove that the person alleged to have been a child was a young person or the person alleged to have been a young person was a child in any case where the acts constituting the alleged offence would equally have been an offence if committed in respect of a young person or child respectively.
- (4) Where a person is charged with an offence under this Act in respect of a person apparently under a specified age it shall be a defence to prove that the person was actually of or over that age.
