General

108 Transitory provisions. E+W

- (1) Without prejudice to the provisions of [F1 the M1 Interpretation Act 1978] with respect to repeals, the transitory provisions set out in the Fifth Schedule to this Act shall have effect for the purposes of the transition to the provisions of this Act from the provisions of the enactments repealed by the M2 Children and Young Persons Act 1932, and by this Act.
- (4) References in any Act or other document to [F3youth courts] under the M3Children Act 1908, shall be construed as including references to such courts under this Act.
- (5) References in any Act or other document to any enactment repealed and re-enacted with or without modifications by this Act ^{F4}. . . shall be construed as including references to the corresponding provision of this Act.
