- 1 *On registration of a birth (including a still-birth)*
- (a) in all cases the age of the mother;
 - (b) where the name of any person is to be entered in the register of births as father of the child, [^{F2}or as a parent of the child by virtue of section 42 or 43 of the Human Fertilisation and Embryology Act 2008,] the age of that person;
 - (c) except where the birth is of an illegitimate child—
 - (i) the date of the parents' marriage [^{F3}or of their formation of a civil partnership] ;
 - (ii) [^{F4}where the parents are married,] whether the mother had been married before her marriage to the father of the child;
 - (iii) [^{F4}where the parents are married,] the number of children of the mother by her present husband and by any former husband, and how many of them were born alive or were still-born.
