



Valuation of Lands (Scotland) Amendment Act 1867

1867 CHAPTER 80 30 and 31 Vict

An Act to define the Duties of the Assessor of Railways in Scotland in making up the Valuation Roll of Railways, and to amend in certain respects the Valuation of Lands (Scotland) Acts. [12th August 1867]

.....^{F4}the assessor shall, when required by any such person, exhibit to him a statement showing the principles and calculations on which the valuation of such assessor is founded, without payment of any fee; and pending the consideration of any appeal against the valuation of such assessor, he shall, if required, be bound to lodge the said statement in court six days before such appeal is to be heard.

9 Liability to Assessment not to be altered by this Act.

Nothing contained in this Act shall alter or affect any classification or power of classification, or any deduction or allowances, or power of making deductions or allowances from gross rental or annual value, made or possessed by any body, persons or person, entitled to impose or levy assessments . . .^{F7}; and nothing contained in this Act shall exempt from or render liable to assessment any person or property not previously exempt from or liable to assessment.
