1892 CHAPTER 39

1 Notice to stockholder of impending transfer of unclaimed stock

The Bank shall during the six months next before any transfer of stock to the National Debt Commissioners in pursuance of section fifty-one of the National Debt Act, 1870, give notice in writing to the stockholder at his registered residence of the impending transfer.
