[^{F3}(1) Where the council of a borough or [^{F4}a district] are licensed [^{F5}to run a public telecommunication system (within the meaning of the Telecommunications Act 1984)], they may . . . ^{F6} borrow money for the purpose . . . ^{F6} and the council may, subject to the provisions . . . ^{F7}of the licence, exercise their powers under the licence throughout the area for which it is granted, although part of that area may be outside the borough or [^{F4}district.]

(2) In the application of this Act to Scotland, a royal or parliamentary burgh shall be substituted for a borough, and a police burgh for [^{F4}a district] . . . ^{F8}
