The Overseas Service Superannuation (Amendment) Order, 1962

Made -Laid before Parliament Coming into Operation

In the exercise of the powers conferred on me by section 2 of the Overseas Service Act, 1958(a), and Article 2 of the Department of Technical Co-operation Order, 1961(b), I hereby, with the consent of the Treasury, make the following Order:-

Citation. and commencement.

- 1.—(1) This Order may be cited as the Overseas Service Superconstruction annuation (Amendment) Order, 1962, and shall be construed as one with the Overseas Service Superannuation Order, 1961(c) (hereinafter called "the principal Order").
 - (2) This Order and the Overseas Service Superannuation Order, 1961, may be cited together as the Overseas Service Superannuation Orders, 1961 and 1962.
 - (3) This Order shall come into operation on the twentieth day of January, 1962.

2. Paragraph 1 of the principal Order is amended by the substitu-Amendment of paragraph tion of the word "Service" for the word "Services". Order.

Amendment of paragraph 20 of principal Order.

3. Paragraph 20 of the principal Order is amended as follows:—

(a) in sub-paragraph (1)—

(i) the word, figures and symbols "sub-paragraphs (3), (6) and (7)" are substituted for the word, figure and symbols "subparagraph (3)", and

(ii) a colon is substituted for the full stop immediately after the word "pension" and before the word "Provided";

(b) the following new sub-paragraphs are added immediately after

sub-paragraph (5)—

- "(6) In the case of an officer referred to in sub-head (b) of sub-paragraph (1) of paragraph 11 of this Order the gratuity mentioned in sub-paragraph (1) of this paragraph shall not be calculated in the manner provided in that sub-paragraph but shall be calculated instead in the manner provided in the next following sub-paragraph.
- (7) The gratuity of an officer to whom sub-paragraph (6) of this paragraph applies shall be equal to one quarter of the

amount of the pension granted to that officer under this Order multiplied by the factor set out in Table 1 of the Fifth Schedule to the Nigeria (Retirement Benefits) Order in Council, 1960(a), that is appropriate to the age of the officer on his birthday last preceding the date of his retirement."
