# The General Grant (Increase) Order 1966

Made - - - - - 9th December 1966

Laid before the House of Commons 12th December 1966

Coming into Operation - - 21st December 1966

The Minister of Housing and Local Government, with the consent of the Treasury and after consultation with the associations of local authorities appearing to him to be concerned and the local authority with whom consultation appeared to him to be desirable, in exercise of the powers conferred on him by section 2(4) of the Local Government Act 1958(a) and of all other powers enabling him in that behalf, hereby makes the following order—

- 1. This order may be cited as the General Grant (Increase) Order 1966 and shall come into operation on the day following the day on which it is approved by a resolution of the Commons House of Parliament,
- 2. For the items set out in column (2) of the subjoined table, prescribed by the General Grant (Increase) Order 1965(b) for the purposes of the general grants for the years 1965-66 and 1966-67 in respect of the matters indicated in column (1), there shall be substituted the items specified in column (3).

### **EXPLANATORY NOTE**

(This Note is not part of the Order.)

This Order, which came into operation on 21st December 1966—

- (a) increases the aggregate amount of the general grants payable under Part I of the Local Government Act 1958 to councils of counties and county boroughs, the councils of London boroughs, the Common Council of the City of London and the Council of the Isles of Scilly; and
- (b) varies certain of the matters prescribed by the General Grant (Increase) Order 1965 in relation to the distribution of those amounts.
