The Teachers Superannuation (Defence Services Schools)
Scheme 1966*Laid before Parliament in draft**Made - - - - - 24th June 1966**Coming into Operation 1st July 1966*

The Secretary of State for Education and Science, with the consent of the Treasury, in exercise of the powers conferred on him by section 21(1)(b) of the Teachers (Superannuation) Act 1925(a), as amended by section 9(2) of the Superannuation (Miscellaneous Provisions) Act 1948(b), hereby makes the following Scheme:—

1. This Scheme may be cited as the Teachers Superannuation (Defence Services Schools) Scheme 1966 and shall come into operation on 1st July 1966.

2.—(1) The Interpretation Act 1889(c) shall apply for the interpretation of this Scheme as it applies for the interpretation of an Act of Parliament.

(2) In this Scheme “the Schemes” means—

The Teachers Superannuation (Royal Naval Schools) Scheme 1956(d);

The Teachers Superannuation (Army Children’s Schools) Scheme 1956(e);
and

The Teachers Superannuation (Royal Air Force (Civilian)) Scheme 1961(f).

(3) Other expressions to which meanings are assigned by the Schemes shall, unless the context otherwise requires, have the same respective meanings for the purposes of this Scheme.

3. Each of the Schemes shall have effect as if, in addition to the modifications of the Act specified therein, the following modification thereof were also specified:—

For any reference to the age of sixty years there shall be substituted a reference to such age as is ascertained by deducting from sixty years a period of three months for each completed year of service, not exceeding twenty, in an unhealthy place.

4. Each of the Schemes shall have effect from 1st April 1966, as if, in substitution for the modification of the Act relating to the amount of employers' contributions specified therein, the following modification were specified:—

Employers' contributions payable under section 9 of the Act in respect of service in an unhealthy place (other than such service by a locally entered teacher employed in Royal Air Force teaching service) shall be the aggregate of—

- (a) an amount equal to twelve per cent. of the salary for the time being of the person; and
- (b) the supplementary contributions for the time being payable under section 4 of the Teachers (Superannuation) Act 1956(a).

EXPLANATORY NOTE

(This Note is not part of the Scheme.)

This Scheme supplements existing arrangements giving additional pension credit for teaching service in Defence Services schools in unhealthy places overseas. The normal pensionable age of sixty will be reduced in each case in proportion to the amount of such service, but will not be reduced below fifty-five. Teachers with forty years or more of service will be able to reckon up to five years of further service after the reduced age.

The Scheme also increases contributions by the amount of supplementary employers' contributions payable under section 4 of the Teachers (Superannuation) Act 1956.

Clause 4 has retrospective effect by virtue of section 9(2) of the Superannuation (Miscellaneous Provisions) Act 1948.
