# The Air Navigation (General) (Jersey) Regulations 1966

Made - - - - - Coming into Operation

25th July 1966 1st August 1966

The Board of Trade in exercise of their powers under Articles 6 (3) (bb), 7 (4) (bb), 10, 21 (2), 22, 23 (4) and 24 (1) and (3) of the Air Navigation Order 1960(a), as amended (b), as applied to Jersey by the Air Navigation (Jersey) Order 1966(c), and as having effect by virtue of the Transfer of Functions (Civil Aviation) Order 1966(d) and of all other powers enabling them in that behalf, hereby make the following Regulations:—

- 1. The Air Navigation (General) Regulations 1960(e), as amended (f), as having effect by virtue of the Transfer of Functions (Civil Aviation) Order 1966 shall apply in relation to Jersey as they apply in relation to the United Kingdom with modifications, adaptations and exceptions specified in the Schedule to these Regulations.
- 2. In these Regulations the expression "Jersey" means the Bailiwick of Jersey and the territorial waters thereof.
- 3. The Interpretation Act 1889(g) shall apply for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament.
- 4. These Regulations may be cited as the Air Navigation (General) (Jersey) Regulations 1966, and shall come into operation on 1st August 1966.

#### **SCHEDULE**

Modifications and adaptations of and exceptions from the Air Navigation (General) Regulations 1960 as amended

- 1. Any reference to the Air Navigation Order 1960 shall be construed as a reference to that Order as applied to Jersey by the Air Navigation (Jersey) Order 1966.
- 2. In Regulation 4 (1) for the words "the United Kingdom" there shall be substituted the word "Jersey".
- 3. In Regulation 5 (4) (c) for the words "the United Kingdom" there shall be substituted the word "Jersey".
  - 4. Regulation 10 shall be omitted.
  - 5. Regulation 10B shall be omitted.
  - 6. Regulation 10C shall be omitted.
  - 7. Regulation 11 shall be omitted.

### **EXPLANATORY NOTE**

(This Note is not part of the Regulations.)

These Regulations apply the Air Navigation (General) Regulations 1960, as amended, to Jersey, subject to the modifications, adaptations and exceptions set out in the Schedule.
