The District Registries Order in Council 1968

Made - - - 8th April 1968

Coming into Operation 23rd April 1968

At the Court at Windsor Castle, the 8th day of April 1968

Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred on Her by section 84 of the Supreme Court of Judicature (Consolidation) Act 1925(a) and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows :—

1. The District Registries Order in Council 1966(b) (which provides that there shall be district registries of the High Court at the places and for the districts specified in the Schedule thereto) shall have effect subject to the amendments set out in the Schedule to this Order.

2.—(1) This Order may be cited as the District Registries Order in Council 1968 and shall come into operation on 23rd April 1968.

(2) The Interpretation Act 1889(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

SCHEDULE

1. In this Schedule any reference to an entry relating to a district registry is a reference to that entry in the Schedule to the District Registries Order in Council 1966 and any reference to the first or second column is a reference to that column in that Schedule.

2. In the entry relating to the Derby District Registry, the word "Ashbourne" in the second column shall be deleted.

3. In the entry relating to the Guildford District Registry, for the words "Aldershot" and "Farnham" in the second column, there shall be substituted the words "Aldershot and Farnham".

4. The entry relating to the Hanley District Registry shall be deleted:

5. After the entry relating to the Stockton-on-Tees District Registry, there shall be inserted the following new entry:—

<i>First Column</i>	<i>Second Column</i>
"Stoke on Trent	Congleton Leek Newcastle-under-Lyme Stoke on Trent Uttoxeter".

6. In the entry relating to the Northampton District Registry, the words "Bletchley and Buckingham" and "Leighton Buzzard" in the second column shall be deleted, and the words "Bletchley and Leighton Buzzard" shall be inserted therein above the word "Kettering".

7. In the entry relating to the Scunthorpe District Registry, the words "Barton-on-Humber" in the second column shall be deleted.

8. In the entry relating to the Torquay District Registry, the word "Totnes" in the second column shall be deleted.

9. The entry relating to the West Hartlepool District Registry shall be deleted.

10. After the entry relating to the Harrogate District Registry, there shall be inserted the following new entry:—

<i>First Column</i>	<i>Second Column</i>
"Hartlepool	Hartlepool".

11. In the entry relating to the Worcester District Registry, the word "Bromyard" in the second column shall be deleted.

12. In the entry relating to the Yeovil District Registry, the words "Axminster" and "Chard" in the second column shall be deleted, and the words "Axminster and Chard" shall be inserted above the word "Bridport".

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends the District Registries Order in Council 1966 by altering the names of the Hanley District Registry and the West Hartlepool District Registry, which will in future be known as the Stoke on Trent District Registry and the Hartlepool District Registry respectively. It also takes account of certain changes which have been made in the names and districts of county courts.
