The Transport (London) Act 1969 (Commencement No. 1) Order 1969

The Minister of Transport in exercise of his powers under section 47 of the Transport (London) Act 1969(a) and of all other enabling powers hereby makes the following Order:—

- 1. This Order may be cited as the Transport (London) Act 1969 (Commencement No. 1) Order 1969.
- 2. The provisions of the Transport (London) Act 1969 (hereinafter referred to as "the Act") specified in the first column of the Schedule to this Order (which relate to the subject matter specified in the second column of that Schedule in relation to those provisions) and in the Appendix to that Schedule shall come into force on the 8th August 1969.
