**The Prices and Incomes Act 1966 (Continuation of Part II)
Order 1969***Laid before Parliament in draft**Made - - - 19th December 1969*

At the Court at Buckingham Palace, the 19th day of December 1969

Present,

The Queen's Most Excellent Majesty in Council

Whereas Her Majesty by Order in Council(a) made under section 6 of the Prices and Incomes Act 1966(b) brought into force sections 7 to 22 (inclusive) of Part II of the said Act of 1966 for a period of twelve months beginning with the 12th August 1967, which sections were continued in force by section 1 of the Prices and Incomes Act 1968(c):

And whereas it is provided by section 13(4) of the said Act of 1968 that section 1 of that Act shall cease to have effect at the end of the year 1969:

And whereas it is provided by paragraph 1 of Schedule 3 to the said Act of 1968, as applied by the said section 13(4), that the provision made by section 6(1) of the Act of 1966 in relation to extension of a period specified in an Order in Council under that section for the bringing into force of sections 7 to 22 of that Act shall have effect in like manner on the expiration of section 1 of the said Act of 1968:

And whereas the Secretary of State in pursuance of section 6(1) of the Act of 1966 has laid copies of the draft of this Order before Parliament, having first consulted with such organisations appearing to her to represent to a substantial extent the interests of those particularly concerned with the Order:

And whereas the said draft has been approved by a resolution of each House of Parliament:

Now, therefore, Her Majesty, in pursuance of the power conferred upon Her by section 6(1)(b) of the said Act of 1966, and of all other powers enabling Her in that behalf is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1.—(1) This Order may be cited as the Prices and Incomes Act 1966 (Continuation of Part II) Order 1969.

(2) The Interpretation Act 1889(d) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

2. The period during which the provisions of Part II of the Prices and Incomes Act 1966, that is to say, sections 7 to 22 (inclusive) thereof, continue in force shall be extended by a further period of twelve months beginning on 1st January 1970.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order continues in force for a further period of 12 months, beginning with 1st January 1970, those provisions of Part II of the Prices and Incomes Act 1966 (relating to notices and standstills) which were first brought into force by Order in Council on 12th August 1967 and further continued in force until the end of the year 1969 by virtue of section 1 of the Prices and Incomes Act 1968.
