# The Local Government (Allowances to Members) (Prescribed Bodies) Regulations 1970

Made	27th July 1970
Laid before Parliament	3rd August 1970
Coming into Operation	10th August 1970

The Minister of Housing and Local Government, in exercise of his powers under sections 111, 115 and 117 of the Local Government Act 1948(a) and of all other powers enabling him in that behalf, hereby makes the following regulations:—

### Citation and commencement

- 1.—(1) These regulations may be cited as the Local Government (Allowances to Members) (Prescribed Bodies) Regulations 1970, and shall come into operation on 10th August 1970.
- (2) These regulations and the Local Government (Allowances to Members) (Prescribed Bodies) Regulations 1967 and 1968(b) may be cited together as the Local Government (Allowances to Members) (Prescribed Bodies) Regulations 1967 to 1970.

#### Interpretation

- 2.—(1) In these regulations "the Act of 1948" means the Local Government Act 1948.
- (2) The Interpretation Act 1889(c) applies for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

Prescription of bodies for the purpose of Part VI of the Act of 1948

3. The following bodies are hereby prescribed as bodies to which Part VI of the Act of 1948 (which makes provision in relation to allowances to members of local authorities and other bodies) shall apply, that is to say, children's regional planning committees established in pursuance of section 35 of the Children and Young Persons Act 1969(d).

Amendment of the Local Government (Allowances to Members) (Prescribed Bodies) Regulations 1967

4. In the list of bodies prescribed by regulation 3 of the Local Government (Allowances to Members) (Prescribed Bodies) Regulations 1967 the entries relating to the Dover Harbour Board and the Southampton Harbour Board shall be omitted.

## **EXPLANATORY NOTE**

(This Note is not part of the Regulations.)

Members of bodies to which Part VI of the Local Government Act 1948 applies are entitled to financial loss, travelling and subsistence allowance in respect of the performance of their duties. The Regulations—

- (1) prescribe children's regional planning committees as such bodies;
- (2) terminate the prescription of certain harbour boards.
