**The Road Vehicles (Excise) (Prescribed Particulars)
 (Amendment) Regulations 1970**

<i>Made - - - -</i>	<i>12th August 1970</i>
<i>Laid before Parliament</i>	<i>25th August 1970</i>
<i>Coming into Operation</i>	<i>1st September 1970</i>

The Minister of Transport in exercise of his powers under sections 12(1) (as substituted by section 6(2) of the Finance Act 1969(a)), 16(3) and 23 of the Vehicles (Excise) Act 1962(b), and of all other enabling powers, hereby makes the following Regulations:—

1.—(1) These Regulations shall come into operation on the 1st September 1970 and may be cited as the Road Vehicles (Excise) (Prescribed Particulars) (Amendment) Regulations 1970.

(2) The Interpretation Act 1889(c) shall apply for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament.

2. The Road Vehicles (Excise) (Prescribed Particulars) Regulations 1966(d), as amended (e), shall have effect as though—

(1) in Regulation 7, after the words “Regulations 1969” there were inserted the words “and as further amended by the Road Vehicles (Registration and Licensing) (Amendment) (No. 2) Regulations 1970(f)”;

(2) in the form VE.7 as set out in Schedule 2 to the Regulations, after the words “(VEHICLE TESTER)” there were inserted the following words
 “*mechanically propelled vehicles kept and used by me solely for the purposes of conducting research and development in the course of my business as a manufacturer of mechanically propelled vehicles (MOTOR TRADER)”;

(3) in the form VE.1/4 as set out in the said Schedule, in paragraph 7 for the words “6 cwt” there were substituted the words “8 cwt”.

These Regulations further amend the Road Vehicles (Excise) (Prescribed Particulars) Regulations 1966 by making minor changes in the declaration to be made by an applicant for a trade licence and in the particulars to be furnished by owners of invalid vehicles.
