The Goods Vehicles (Plating and Testing) (Amendment)

Regulations 1970

The Minister of Transport, in exercise of his powers under section 9(1) and (6) of the Road Safety Act 1967(a) as amended by section 148 of the Transport Act 1968(b) and of all other enabling powers, and after consultation with representative organisations in accordance with the provisions of section 260(2) of the Road Traffic Act 1960(c), as applied by section 29(6) of the said Act of 1967, hereby makes the following Regulations:—

1.—(1) These Regulations shall come into operation on the 1st October 1970 and may be cited as the Goods Vehicles (Plating and Testing) (Amendment) Regulations 1970.

(2) The Interpretation Act 1889(d) shall apply for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament.

2. The Goods Vehicles (Plating and Testing) Regulations 1968(e), as amended (f), shall have effect as though—

(a) In Part IV of Schedule 4—

- (i) at the end of column 1 of paragraphs 10, 11 and 12 there were added respectively the words “or January 1970”, “or February 1970”, “or March 1970”;
- (ii) in column 1 of paragraph 13 for the words “1st January 1970” there were substituted the words “1st July 1970”;

(b) in Part V of Schedule 4—

- (i) for the heading to that Part there were substituted the following heading—
“Dates relating to trailers manufactured on or after 1st January 1968 and first sold or supplied by retail before 1st April 1970 and to trailers manufactured on or after 1st January 1968 and before 1st January 1970 and not sold or supplied by retail before 1st July 1970”;
- (ii) at the end of column 1 of paragraphs 10, 11 and 12 there were added respectively the words “or January 1970”, “or February 1970”, “or March 1970”;

(iii) after paragraph 12 there were added the following paragraph—

“13. Trailers manufactured
during 1968 or 1969
and not sold or
supplied by retail
before 1st July 1970 | 1st October 1970 | 1st January 1971”.
