# The National Ports Council Provision of Funds (Variation) Scheme 1970 (Confirmation) Order 1970

Made - - - 1st October 1970 Laid before Parliament 13th October 1970 Coming into Operation 14th October 1970

The Minister of Transport (hereinafter referred to as "the Minister"), in exercise of the powers conferred upon him by section 4(5) and (7) of the Harbours Act 1964(a) (hereinafter referred to as "the Act") and of all other enabling powers, hereby makes the following Order:—

- 1.—(1) The Minister hereby confirms the scheme submitted to him by the National Ports Council in pursuance of section 4(7) of the Act for the variation of the National Ports Council Provision of Funds Scheme 1965(b) as amended (c).
- (2) The scheme is set out in the Schedule to this Order and shall come into force on the date specified in Article 2(1) of this Order.
- 2.—(1) This Order may be cited as the National Ports Council Provision of Funds (Variation) Scheme 1970 (Confirmation) Order 1970 and shall come into operation on 14th October 1970.
- (2) The Interpretation Act 1889(d) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

### **SCHEDULE**

### NATIONAL PORTS COUNCIL

SCHEME UNDER SECTION 4 OF THE HARBOURS ACT 1964

The National Ports Council, in exercise of their powers under section 4 of the Harbours Act 1964, hereby make the following scheme:—

1. This scheme may be cited as the National Ports Council Provision of Funds (Variation) Scheme 1970.

- 2.—(1) In this scheme "the principal scheme" means the National Ports Council Provision of Funds Scheme 1965 as varied by the National Ports Council Provision of Funds (Variation) Scheme 1966, the National Ports Council Provision of Funds (Variation) Scheme 1967, the National Ports Council Provision of Funds (Variation) Scheme 1968 and the National Ports Council Provision of Funds (Variation) Scheme 1969 and any expression to which a meaning is attributed by the principal scheme shall, unless the context otherwise requires, have the meaning so attributed.
- (2) The Interpretation Act 1889 shall apply for the interpretation of this scheme as it applies for the interpretation of an Act of Parliament.
- 3. The principal scheme shall be varied by the substitution in article 5 of the figure "£600,000" for the figure "£450,000".

## **EXPLANATORY NOTE**

By this Order the Minister of Transport confirms a Scheme made and submitted to him by the National Ports Council under section 4 of the Harbours Act 1964 for varying the National Ports Council Provision of Funds Scheme 1965. The Variation Scheme as so confirmed is set out in the Schedule.
