# The Rules of Procedure (Army) (Amendment) Rules 1970

Made	23rd February 1970
Laid before Parliament	2nd March 1970
Coming into Operation	16th March 1970

The Secretary of State in exercise of the powers conferred upon him by sections 103, 104, 105 and 106 of the Army Act 1955(a) and of all other powers enabling him in that behalf hereby makes the following Rules:—

#### Citation and commencement

1. These Rules may be cited as the Rules of Procedure (Army) (Amendment) Rules 1970 and shall come into operation on 16th March 1970.

#### Interpretation

2. The Interpretation Act 1889(b) shall apply to the interpretation of these Rules as it applies to an Act of Parliament.

Amendment to the Rules of Procedure (Army) 1956(c)

- 3.—(1) The Rules of Procedure (Army) 1956, as amended (d), shall be further amended in accordance with the following provisions of this Rule.
- (2) In Rule 100, for the words "four pence for every folio of 72 words" there shall be substituted the words "two shillings for every sheet".
- (3) In Part (1) of the Second Schedule (Commencement of Charge-Sheets) there shall be added at the end:—

### "Ulster Defence Regiment Act 1969(e).

(4) In Part (2) of the Second Schedule (Statements of Offences) there shall be added at the end:—
