The Wireless Telegraphy (Broadcast Licence Charges & Exemption) Amendment (No. 2) Regulations 1971

Made	23rd February	1971
Laid before Parliament	1st March	1971
Coming into Operation	31st March	1971

The Minister of Posts and Telecommunications, with the consent of the Treasury, in the exercise of his powers under sections 1 and 2 of the Wireless Telegraphy Act 1949(a), by the said sections as extended to the Channel Islands by the Wireless Telegraphy (Channel Islands) Order 1952(b) and by the said sections as extended to the Isle of Man by the Wireless Telegraphy (Isle of Man) Order 1952(c), and of every other power enabling him in that behalf hereby makes the following Regulations:-

- 1.—(1) These Regulations shall come into operation on 31st March 1971 and may be cited as the Wireless Telegraphy (Broadcast Licence Charges & Exemption) Amendment (No. 2) Regulations 1971.
- (2) The Interpretation Act 1889(d) shall apply for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament.
- 2. The Wireless Telegraphy (Broadcast Licence Charges & Exemption) Regulations 1970(e) as amended (f) shall be further amended as follows:
 - (a) by substituting in paragraph (3) of Regulation 4 thereof for the words "1st April 1971", the words "1st July 1971";
 - (b) by substituting for the figures "£6 10s. 0d. (£6.50)" and "£11 10s. 0d. (£11·50)" wherever they occur in the third column of Schedule 3 thereof the figures "£7" and "£12" respectively.
