The Assessor of Public Undertakings Valuation Roll (Procedure Dates) (Scotland) Amendment Order 1971

Made 26th March 1971

Coming into Operation 27th March 1971

In exercise of the powers conferred on me by section 22(5) of the Railways (Valuation for Rating) Act 1930(a), section 3 of the Rating and Valuation (Scotland) Act 1952(b), section 13(1) of the Valuation and Rating (Scotland) Act 1956(c) as read with section 22(d) of the Local Government (Financial Provisions) (Scotland) Act 1963(d) and of all other powers enabling me in that behalf, I hereby make the following order:-

- 1. This order may be cited as the Assessor of Public Undertakings Valuation Roll (Procedure Dates) (Scotland) Amendment Order 1971 and shall come into operation on 27th March 1971.
- 2. The Interpretation Act 1889(e) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.
- 3. In the year 1971/72 and any subsequent year of revaluation for the dates specified in the Assessor of Public Undertakings Valuation Roll (Procedure Dates) (Scotland) Order 1953(f) as the last dates for certain purposes, being the dates set out in column 2 of the Schedule to this order opposite to those purposes set out in column 1, there shall be substituted the dates set out in column 3 opposite to the said purposes.
