The Potato Marketing Scheme (Amendment) Order 1971

Made - - - 29th April 1971

Whereas the Potato Marketing Board duly submitted to the Minister of Agriculture, Fisheries and Food, the Secretary of State concerned with agriculture in Scotland and the Secretary of State for Wales (hereinafter called "the Ministers") certain amendments of the Potato Marketing Scheme 1955(a), as amended (b), which amendments, as subsequently modified by the Ministers, are set forth in the Schedule hereto:

And Whereas the Ministers laid before each House of Parliament the amendments set forth in the said Schedule and the House of Commons resolved on 28th April 1971 and the House of Lords resolved on 20th April 1971 that they should be approved:

Now, therefore, the Ministers in pursuance of section 2 of the Agricultural Marketing Act 1958(c) and Schedule 1 to that Act, as read with the Transfer of Functions (Wales) Order 1969(d), acting jointly, hereby make the following order:—

1. This order may be cited as the Potato Marketing Scheme (Amendment) Order 1971.

2. The amendments of the Potato Marketing Scheme 1955, as amended, which are set forth in the Schedule hereto are hereby approved and shall come into operation on 10th May 1971.

SCHEDULE

The Potato Marketing Scheme 1955, as amended, shall be further amended as follows:-

1. By substituting in paragraph 40(1) thereof for the words from "in addition" to "in excess of 24" inclusive the words "in addition a fee not exceeding one new penny for each entry copied in excess of 24".

2. By substituting in paragraph 56 thereof, as amended by section 10 of the Decimal Currency Act 1969(a), for the words "twelve and a half new pence" the words "ten new pence".

3. By substituting for sub-paragraph (a) of paragraph 84(2) thereof the following sub-paragraph:—

"(a) an ordinary contribution as provided for in sub-paragraph (3) of this paragraph, and".

4. By substituting for sub-paragraph (3) of paragraph 84 thereof the following sub-paragraph:—

"(3)(a) For the purposes of this sub-paragraph (3)—

"the actual rate" means the rate of ordinary contribution payable by registered producers in accordance with the provisions of this sub-paragraph;

"average yield" means the average yield in tons per acre of potatoes harvested in Great Britain as ascertained in respect of each calendar year by reference to a certificate issued to the Board by the Minister of Agriculture, Fisheries and Food on the basis of information available to the said Minister on the 15th day of January in the next succeeding calendar year and calculated to the nearest 0-1 of a ton;

"the formula rate" means the rate calculated in accordance with the provisions of sub-paragraph (c) hereof;

Provided that-

- (i) if a formula rate cannot be calculated for any calendar year because any of the factors for such calculation are not available then the formula rate shall be deemed to be equivalent to the formula rate for the previous calendar year;
- (ii) for the calendar year 1971 the formula rate shall be deemed to be $\pounds 4.03$;

"guaranteed price" means the guaranteed price for potatoes determined in pursuance of an order under section 1 of the Agriculture Act 1957(b).

(b) The ordinary contribution in respect of any calendar year shall be at a rate per acre, and proportionately for each quarter of an acre, of the acreage of potatoes planted in that calendar year on land in the occupation of the registered producer at noon on such day in the month of May or June in that year as the Board prescribe.

(c) The actual rate of ordinary contribution in respect of any calendar year shall not exceed the formula rate which shall be calculated for every calendar year subsequent to 1971 by multiplying the formula rate for the previous calendar year by—

- (i) the guaranteed price determined in respect of the period of twelve months commencing with the first day of August in the previous calendar year divided by the guaranteed price determined in respect of the period of twelve months commencing with the first day of August in the calendar year before that, and by
- (ii) the total of the average yields for the three previous calendar years divided by the total of the average yields for the first three of the four previous calendar years.

(d) The actual rate of ordinary contribution for any calendar year subsequent to 1971 shall not exceed by more than 6 per cent. such rate for the preceding calendar year unless any such actual rate, not exceeding the formula rate for that calendar year, has been approved on a poll of registered producers, the result of which shows that there have voted in favour of such greater rate (i) not less than two thirds of the registered producers who are capable of producing not less than two thirds of the quantity of potatoes which all the registered producers voting on the poll are capable of producing.

(e) Part IV of this Scheme shall apply to any poll held for the purposes of sub-paragraph (d) hereof as it applies to a poll held in connection with a proposal for the amendment or revocation of this Scheme, except that paragraph 49 shall not apply and that the number of registered producers to be shown in the certificate provided for in paragraph 51(2) shall be the number of registered producers who voted in favour of the greater rate and against it respectively. Such certificate and any copy thereof purporting to be certified in writing by the Chairman or Vice-Chairman or Secretary of the Board to be a true copy shall be conclusive evidence of the result of the poll and that the poll was duly held.

(f) Any certificate purporting to be signed by or on behalf of the accountant or firm of accountants appointed for the purpose of paragraph 54 of this Scheme by the registered producers at the last preceding annual meeting and specifying the formula rate in respect of any calendar year for the purpose of sub-paragraph (a) hereof and any copy of any such certificate purporting to be certified in writing by the Chairman, Vice-Chairman, General Manager or Secretary of the Board to be a true copy thereof, shall be conclusive evidence that the rate so specified is the correct formula rate."

5. By inserting at the end of paragraph 84(6)(a) thereof the words "and the Board may, if they think fit, prescribe different classes of exceptional circumstances in relation to ordinary contributions and excess acreage contributions respectively.".

6. By substitution in paragraph 84(6)(b) thereof for the words "by way of excess acreage contribution" the words "by way of ordinary contribution or excess acreage contribution or both."

EXPLANATORY NOTE

(This Note is not part of the Order.)

This order approves further amendments to the Potato Marketing Scheme 1955, as amended, which are set out in the Schedule. The principal amendments provide for—

- (1) an increase in the maximum rate of ordinary contribution by registered producers from £3 to £4.03 per acre for the 1971 crop;
- (2) the maximum rate of ordinary contribution not being changed thereafter except in proportion to changes in the guaranteed price and in the average yield for the preceding three years;
- (3) subject to this maximum the actual rate of ordinary contribution for any year not being higher than 6 per cent. above the actual rate for the last preceding year unless the provisions of the Agricultural Marketing Act 1958 and the Scheme relating to polls on amendments to the Scheme have been followed;
- (4) the Board having power to waive or reduce the ordinary contribution in exceptional circumstances beyond a registered producer's control, subject to the circumstances being defined by the Board in advance.

LETTERS PATENT passed under the Great Seal of the Realm amending the Tasmania Letters Patent 1900 and 1920.

Dated: 25th May, 1971

ELIZABETH THE SECOND, by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Our other Realms and Territories Oueen. Head of the Commonwealth, Defender of the Faith.

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING!

Whereas by certain Letters Patent under the Great Seal, bearing date at Westminster the Twenty-ninth day of October 1900, Her Majesty Queen Victoria did constitute, order and declare that there should be a Governor in and over Our State of Tasmania and its Dependencies in the Commonwealth of Australia (which said State and its Dependencies are therein and hereinafter called "the State"):

And whereas by the Thirteenth Clause of the aforesaid Letters Patent as amended by Letters Patent bearing date the Thirty-first day of August 1920, provision was made for the appointment of a Deputy to the Governor in the event of his having occasion to be temporarily absent for a short period from the State:

And whereas We are minded to amend further the aforesaid Thirteenth Clause of the aforesaid Letters Patent:

Now KNOW YE that We do hereby declare Our Will and Pleasure. and direct and ordain as follows: -

I. The aforesaid Thirteenth Clause of the aforesaid Letters Patent is hereby amended by the insertion after the words "temporarily absent for a short period from the seat of Government or from the State," of the words "or if by reason of any illness he considers it desirable so to do,"; and by the insertion of the words "or illness" both after the words "during such temporary absence" and after the 29th October words "on behalf of the Governor during such absence".
