**The Registration of Births, Deaths and Marriages (Fees)  
(Scotland) Order 1972**

In exercise of the powers conferred on me by section 5 of and Schedule 3 to the Public Expenditure and Receipts Act 1968(a), and of all other powers enabling me in that behalf, I hereby make the following order: —

*Citation and commencement*

1. This order may be cited as the Registration of Births, Deaths and Marriages (Fees) (Scotland) Order 1972 and shall come into operation on 1st October 1972.

*Interpretation*

2. The Interpretation Act 1889(b) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

*Variation of Fees*

3. The fees payable under the enactments specified in column 2 of the schedule to this order in respect of the certificates described in column 3 of that schedule shall be the amounts respectively specified in column 4 thereof.

*Enactment repealed*

4. The fee specified by subsection (2) of section 97 of the Friendly Societies Act 1896(c) for more certificates than one of the same birth or death shall be that payable under subsection (1) of the said section and in consequence the said subsection (2) is hereby repealed.

*Revocation*

5. The Registration of Births, Deaths and Marriages (Fees) (Scotland) Order 1968(d) is hereby revoked.

*(This Note is not part of the Order.)*

This Order supersedes the Registration of Births, Deaths and Marriages (Fees) (Scotland) Order 1968 and increases the fee payable for a certificate of birth, death or marriage issued for special purposes under certain statutory provisions, from ten pence to fifteen pence. It also repeals section 97(2) of the Friendly Societies Act 1896.
