**The Awards (First Degree, etc. Courses) (Amendment)
Regulations 1973**

Made - - - 12th July 1973
Laid before Parliament 24th July 1973
Coming into Operation 1st September 1973

The Secretary of State for Education and Science, in exercise of the powers conferred by section 1 of the Education Act 1962(a) and vested in her(b), hereby makes the following regulations.

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Awards (First Degree, etc. Courses) (Amendment) Regulations 1973 and shall come into operation on 1st September 1973.

(2) In these regulations “the principal regulations” means the Awards (First Degree, etc. Courses) Regulations 1971(c) as amended by the Awards (First Degree, etc. Courses) (Amendment) Regulations 1972(d).

(3) The Interpretation Act 1889(e) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

Requirements for ordinary maintenance

2. The provisions of the principal regulations specified in the first column below shall have effect with the substitution for the amounts specified in the second column of the amounts specified in the third column.

Resources

3.—(1) At the end of paragraph 1 (student's income) of schedule 2 to the principal regulations there shall be added as a note—

“Note: the reduction for income tax is to be made by calculating the tax payable on the income received in the year as if that year were a year of assessment within the meaning of the Income Tax Acts (the necessary apportionment being made in any case where the relevant provisions of those Acts change during the year).”

(2) In paragraph 4 (parental contribution) of schedule 2, for subparagraph (1) there shall be substituted—

“4.—(1) Subject to subparagraph (2) below, the parental contribution shall be—

(a) in any case in which the residual income is not less than £1,500 and not more than £1,999, £30 with the addition of £1 for every complete £5 by which it exceeds £1,500; and

(b) in any case in which the residual income is not less than £2,000, £130 with the addition of £1 for every complete £10 by which it exceeds £2,000;

and in any case in which the residual income is less than £1,500 the parental contribution shall be nil.”

Miscellaneous amendments relating to requirements

4.—(1) The provisions of schedule 1 to the principal regulations specified in the first column below shall have effect subject to the amendments specified in the second column.

Paragraph 2(1)	For the words “maintenance in respect of his attendance at the course during term” there shall be substituted the words “ordinary maintenance”.
Paragraph 3(4)	The words “(otherwise than on an exchange basis)” shall be omitted.
Paragraph 4(1)	For the word “fortnight” in each place where it occurs there shall be substituted the word “week” and for the references to £9·80, £19·60 and £16·80 there shall be substituted references to £4·90, £9·80 and £8·40 respectively.
Paragraph 4(2)	For the references to 26 weeks and 31 weeks there shall be substituted references to 25 weeks 3 days and 30 weeks 3 days respectively.
Paragraph 6(1)(c)	At the beginning there shall be inserted the words “(in the case of a student attending a course at an establishment which is not a university)” and there shall be omitted the words from “but” to “establishment” (both inclusive).
Paragraph 8(1)(b)	There shall be omitted “(b) dentistry” and “and (b) £60 respectively.”

Paragraph 14(2)(b) For the words after “£485” (as substituted by regulation 2 above) there shall be substituted the words “and any relevant sum specified by paragraph 11”.

(2) In paragraph 2 of schedule 4 (sandwich courses), for the references to 31 weeks in subparagraphs (a) and (b) there shall be substituted references to 30 weeks 3 days.

These Regulations increase the rates of ordinary maintenance prescribed by the Awards (First Degree, etc. Courses) Regulations 1971 as amended, modify the provisions in those Regulations relating to the parental contribution and make other amendments of a minor character.
