The Secretary of State for the Environment in exercise of powers conferred by section 23 of the Water Act 1945(a) and now vested in him(b) and of all other powers enabling him in that behalf, hereby orders as follows: -

1.—(1) This order may be cited as the North West Sussex (Hardham Citation and Intake) Order 1973 and shall come into operation on 1st August 1973. commence-

- (2) The North West Sussex Water Orders 1959 to 1971 and this order may be cited together as the North West Sussex Water Orders 1959 to 1973.
 - 2. In this order, unless the context otherwise requires—

Interpretation.

"the Board" means the North West Sussex Water Board;

"the Third Schedule" means the Third Schedule to the Water Act 1945;

"the undertaking" means the undertaking of the Board as from time to time authorised by any enactment.

3.—(1) The Board may construct and maintain on the land described Construction in Schedule 1 to this order an intake on the river Rother adjacent to and and maintenon the west side of the intake authorised by section 3 of the North West Sussex Joint Water Order 1950(c).
