The Provision of Milk and Meals (Amendment No. 2)

Regulations 1973

<i>Made</i> - - - -	23rd July 1973
<i>Laid before Parliament</i>	3rd August 1973
<i>Coming into Operation</i>	1st September 1973

The Secretary of State for Education and Science and the Secretary of State for Wales, in joint exercise of the powers conferred by section 49 of the Education Act 1944(a) as amended by section 1 of the Education (Milk) Act 1971(b) and vested in them(c), hereby make the following regulations—

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Provision of Milk and Meals (Amendment No. 2) Regulations 1973 and shall be included among the regulations which may be cited together as the Provision of Milk and Meals Regulations 1969 to 1973.

(2) These regulations shall come into operation on 1st September 1973.

(3) The Interpretation Act 1889(d) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

Amendment of Regulations

2.—(1) Regulation 10(4) (remission of charges) of the Provision of Milk and Meals Regulations 1969(e) as amended (f) shall have effect subject to the addition at the end of the words—

“and may include provision for the remission of the charge under subparagraph (c) in the case of any parent in whose case the charge under subparagraph (b) is remitted in pursuance of this paragraph.”

(2) Schedule 1 (determination of financial hardship) to the Provision of Milk and Meals Regulations 1969 as amended shall have effect subject to the substitution for the table and the first note in paragraph 1 (net income scale) of the following table and note.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations enable a local education authority to remit the charge for other meals and refreshment in a special school for a pupil for whom they remit the charge for the school dinner and amend the provisions of the existing Regulations for the calculation of a parent's income for the purpose of determining his entitlement to the remission of the charge for school dinner.
