**The Hags to Ingliston (Connecting Roads) Special Roads
Scheme 1973**

5th October 1973

Coming into Operation

19th October 1973

The Secretary of State in exercise of powers conferred on him by sections 1 and 2 of the Special Roads Act 1949(a), (hereinafter referred to as "the Act"), as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955(b), and of all other powers enabling him in that behalf, and having complied with the provisions of Part I of the First Schedule to the Act as amended by section 51 and Schedule 1 of the Roads (Scotland) Act 1970(c), hereby makes the following scheme:—

1. This scheme may be cited as the Hags to Ingliston (Connecting Roads) Special Roads Scheme 1973, and shall come into operation on 19th October 1973.

2.—(1) The Interpretation Act 1889(d) shall apply for the interpretation of this scheme as it applies for the interpretation of an Act of Parliament.

(2) In this scheme—

"the plan" means the plan numbered R/SR/5/33 and marked "The Hags to Ingliston (Connecting Roads) Special Roads Scheme 1973", signed and sealed with reference to this scheme and deposited at the office of the Scottish Development Department, St Andrew's House, Edinburgh. A certified copy of the said plan has been deposited at the office of the County Council of the County of Stirling, County Offices, Viewforth, Stirling.

"the special roads" means the special roads referred to in Article 3 of this scheme, the centre lines of which are shown by heavy black lines on the plan.

"the motorway" means the special road to be provided under the Cumbernauld to Ingliston Special Road Scheme 1970(e).

3. The provision along the routes described in the Schedule to this scheme of special roads for use of traffic of Classes I and II of the classes of traffic set out in Schedule 2 to the Act as varied by the Special Roads (Classes of Traffic) (Scotland) Order 1971(f), is hereby authorised.

SCHEDULE

THE ROUTES OF THE SPECIAL ROADS

Junction between the motorway and the Glasgow-Stirling Trunk Road (A.80) trunk road links to the Falkirk-Glasgow Road (A.803) in the County of Stirling.

(1) In the following sub-paragraph "the reference point" means the point of conjunction of the motorway and the A80 as shown by the reference letter "A" on the plan.

(2) The routes described in this sub-paragraph are shown by heavy black lines and numbered 1 and 2 respectively on the plan and are routes:—

- (a) starting at a point on the A80 western link road approximately 152 metres (167 yards) north of the reference point and proceeding north eastwards to join the northbound carriageway of the motorway at a point approximately 549 metres (600 yards) north east of the reference point.
- (b) starting at a point on the southbound carriageway of the motorway approximately 335 metres (367 yards) north east of the reference point and proceeding south westwards to join the A80 eastern link road approximately 91 metres (100 yards) east of the reference point.
