The Carriage by Railway (Parties to Convention) (Amendment) Order 1973

At the Court at Buckingham Palace, the 12th day of December 1973

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred upon Her by sections 2(1) and (2) and 11 of the Carriage by Railway Act 1972(a), and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

- 1. This Order may be cited as the Carriage by Railway (Parties to Convention) (Amendment) Order 1973.
- 2. The Carriage by Railway (Parties to Convention) Order 1972(b) is hereby amended by substituting the Schedule to this Order for Schedule 1 to that Order, and by adding in Schedule 2 to that Order, after the entry "The Republic of Finland" the words "The German Democratic Republic" and after the entry "The German Democratic Republic" the words "The People's Republic of Hungary".

EXPLANATORY NOTE

(This Note is not part of the Order.)

The Carriage by Railway (Parties to Convention) Order 1972 certifies that various States, listed in Schedule 1 to that Order, are Contracting States for the purposes of the Additional Convention to the International Convention concerning the Carriage of Passengers and Luggage by Rail signed at Berne, 1966 (Cmnd. 4969), and that certain of those States, listed in Schedule 2 to the Order, have made a declaration in accordance with Article 1(2) of the Convention. Since that Order was made the German Democratic Republic, the People's Republic of Hungary and the Kingdom of Morocco have become Contracting States to the Convention, and the German Democratic Republic and the People's Republic of Hungary have made a declaration in accordance with Article 1(2). The revised entry into force date for the Republic of Austria is made necessary by a correction issued by the depositary Government. The present Order amends the principal Order accordingly.
