The Police Cadets (Scotland) Amendment Regulations 1974

Made	18 th July 1974
Laid before Parliament	31 st July 1974
Coming into Operation	21 st August 1974

In exercise of the powers conferred on me by section 27 of the Police (Scotland) Act 1967(a), and of all other powers enabling me in that behalf, and after consulting the Police Council for the United Kingdom in accordance with section 4(4) of the Police Act 1969(b), I hereby make the following regulations:—

Citation

1. These regulations may be cited as the Police Cadets (Scotland) Amendment Regulations 1974.

Operation and effect

- 2. These regulations shall come into operation on 21st August 1974 and shall have effect:—
 - (a) for the purposes of regulation 5(1) thereof, as from 1st September 1973; and
 - (b) for the purposes of regulation 6 thereof, as from 1st April 1974; and
 - (c) for the purposes of regulation 7 thereof, as from 25th May 1974; and
 - (d) for the purposes of regulations 5(2) and 8, as from 21st August 1974.

Interpretation

- 3. In these regulations any reference to the principal regulations is a reference to the Police Cadets (Scotland) Regulations 1968(c), as amended (d).
- **4.** The Interpretation Act 1889(e) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

Uniform and equipment

- **5.**—(1) In regulation 16(1A) of the principal regulations (which relates to uniform and equipment) for the sum "£0·240" there shall be substituted "£0·290".
- (2) In regulation 16(1B) of the principal regulations for "18" there shall be substituted "24" and for the sum "£9 a year" there shall be substituted "£12 a year".

Pay

6. For the Table in Schedule I to the principal regulations (which contains the scales of pay) there shall be substituted the following table:—

Age	Annual Pay
Under 17 years	£711
17 years	£759
18 years	£876
19 years	£909"

- 7.—(1) This regulation shall have effect, notwithstanding anything in the principal Regulations, for the purpose of supplementing the pay of a police cadet.
 - (2) The annual pay of a police cadet shall be increased—
 - (a) with effect from the first day of his pay period first beginning after 24th May 1974 by £62.64, and
 - (b) with effect from the first day of his pay period first beginning after 21st June 1974, by a further £41.76, subject, however, to paragraphs (3) and (4) below.
- (3) Where the Secretary of State is satisfied that the Retail Price Index figure as published on any date falling after 21st June 1974 but before 16th November 1974 exceeds by 12% or more the base figure, that is to say 185.4 he may, in lieu of the increase under paragraph (2) above, or of any increase previously authorised, hereunder, authorise the increase of the annual pay of a police cadet in pursuance of this paragraph and, for the purposes thereof, shall specify—
 - (a) the amount of the increase, being £20.88 in respect of each full 1%, over and above 6%, by which the Retail Price Index figure in question exceeds the base figure; and
 - (b) the date of publication of the Retail Price Index figure in question.
- (4) The annual pay of a police cadet shall be increased in pursuance of an authorisation under paragraph (3) above by the amount specified under subparagraph (a) thereof with effect from the first day of his pay period first beginning after the date specified under paragraph (b) thereof; but, with effect from that day, no increase shall be payable in his case under paragraph (2) or in pursuance of any authorisation under paragraph (3) above given before the authorisation in question was given.

(5) In this regulation the following expressions have the meanings hereby respectively assigned to them, that is to say—

"annual pay" means annual pay determined in accordance with the principal regulations as amended by regulation 6 of these regulations;

"base figure" means the Retail Price Index figure for October 1973;

"pay period" means the period in respect of which a police cadet receives payments by way of pay;

"Retail Price Index figure" means that figure as published by the Department of Employment.

Charge for Board and Lodgings

8. In Schedule II to the principal regulations (which relates to charges for board and lodging) there shall be substituted the sum of "£135" for the sum "£120".

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Police Cadets (Scotland) Regulations 1968.

Regulation 5 provides for an increase in footwear allowance and, in the case of women cadets, in the supply of stockings or tights.

Regulation 6 provides for increases in pay.

Regulation 7 provides for a pensionable addition to pay which, in accordance with the Police Council agreement, falls due by reason of the Retail Price Index rising by a specified amount above the base figure as at October 1973.

Regulation 8 increases charges for board and lodging by £15 a year.

The provision that Regulation 6 shall have retrospective effect is contained in Regulation 2 (made in exercise of the power conferred by section 27(2) of the Police (Scotland) Act 1967).
