EDUCATION, SCOTLAND

The Teachers Superannuation (Contributions) (Scotland) (No. 2) Regulations 1974

Made - - - 26th November 1974
Laid before Parliament 12th December 1974
Coming into Operation 2nd January 1975

In exercise of the powers conferred on me by section 9 of the Superannuation Act 1972(a) and of all other powers enabling me in that behalf, with the consent of the Minister for the Civil Service and after consultation with representatives of education authorities and of teachers and with such representatives of other persons likely to be affected as appear to me to be appropriate, I hereby make the following regulations:—

Citation, commencement and interpretation

- 1.—(1) These regulations may be cited as the Teachers Superannuation (Contributions) (Scotland) (No. 2) Regulations 1974 and shall be included among the regulations which may be cited together as the Teachers Superannuation (Scotland) Regulations 1969 to 1974.
- (2) These regulations shall come into operation on 2nd January 1975 and shall take effect as from 1st December 1973.
- (3) The Interpretation Act 1889(b) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

Alteration in contributions

- 2. The Teachers Superannuation (Financial Provisions) (Scotland) Regulations 1972(c) as amended (d) shall have effect with the substitution—
 - (a) In regulation 5(2) (teacher's contribution), for the words " $6\frac{1}{2}$ per cent" of the words "6 per cent";
 - (b) In regulation 5(3) (employer's contribution), for the words "6½ per cent" of the words "6 per cent"; and
 - (c) In regulation 7A(2) (balance of the new entrant contribution), for the words "13 per cent" of the words "12 per cent".

EXPLANATORY NOTE
