## INDUSTRIAL TRAINING

**The Industrial Training (Engineering Board) Order 1964  
(Amendment) Order 1974**

The Secretary of State, on the recommendation of the Manpower Services Commission, and in exercise of his powers under section 9 of the Industrial Training Act 1964(a), as amended by section 6(1) of, and paragraph 12 of Part I of Schedule 2 to, the Employment and Training Act 1973(b), and of all other powers enabling him in that behalf, hereby makes the following Order:—

*Citation, commencement and interpretation*

1.—(1) This Order may be cited as the Industrial Training (Engineering Board) Order 1964 (Amendment) Order 1974 and shall come into operation on 14th January 1975.

(2) In this Order—

- (a) “the Act” means the Industrial Training Act 1964, as amended by the Employment and Training Act 1973;
- (b) “the Board” means the Engineering Industry Training Board;
- (c) “Levy Order” includes the Industrial Training Levy (Engineering) Order 1965(c), the Industrial Training Levy (Engineering) Order 1967(d), the Industrial Training Levy (Engineering) (No. 2) Order 1967(e), the Industrial Training Levy (Engineering) Order 1968(f), the Industrial Training Levy (Engineering) (No. 2) Order 1967 (Amendment) Order 1968(g), the Industrial Training Levy (Engineering) Order 1969(h), the Industrial Training Levy (Engineering) Order 1970(i), the Industrial Training Levy (Engineering) Order 1971(j), the Industrial Training Levy (Engineering) Order 1972(k), the Industrial Training Levy (Engineering) Order 1973(l) and the Industrial Training Levy (Engineering) (No. 1)

(d) “the 1971 Order” means the Industrial Training (Engineering Board) Order 1971(b);

(3) The Interpretation Act 1889(d) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament and as if this Order, the principal Order and the 1971 Order were Acts of Parliament.

*Amendment of the principal Order*

2. The principal Order (as amended by the 1971 Order) shall be further amended in accordance with the Schedule to this Order, and accordingly the activities in relation to which the Board exercises the functions conferred by the Act upon industrial training boards shall be the activities specified in Schedule 1 to the principal Order as amended by the 1971 Order and this Order.

*Transitional Provisions*

3.—(1) The chairman and other members of the Board on the day upon which this Order comes into operation shall continue to be members of the Board and to hold and vacate their offices in accordance with the terms of the instruments appointing them to be members.

(2) The provisions of this Order shall not—

(a) extend the operation of a levy Order;

(b) affect the operation of a levy Order in relation to the assessment of an employer within the meaning of that Order in respect of an establishment that was engaged in the relevant levy period wholly or mainly in activities included in Schedule 1 to the principal Order as amended by the 1971 Order and this Order;

(c) affect the operation of any assessment notice served by the Board under the provisions of a levy Order before the day upon which this Order comes into operation or any appeal or other proceedings arising out of any such notice.

**SCHEDULE**  
**AMENDMENTS TO THE PRINCIPAL ORDER**  
**(AS AMENDED BY THE 1971 ORDER)**

1. In this Schedule the expression "the Schedule" means Schedule 1 to the principal Order (as amended by the 1971 Order).
2. In paragraph 1 of the Schedule after sub-paragraph (i) insert—  
 "(iA) the assembly, construction, erection, installation or fitting on site of any of the chemical, electrical or mechanical apparatus, machinery or plant of a chemical works, gas-making or gas treatment works, nuclear or thermal power station, hydro-electric station, oil refinery or oil terminal, metal smelter, steel mill, paper mill or brewery."
3. In paragraph 2 of the Schedule—
  - (a) in sub-paragraph (e)(iii) for the words "the Gas Council or an Area Gas Board" substitute the words "the British Gas Corporation";
  - (b) in sub-paragraph (e)(vi) for the words "statutory water undertakers within the meaning of the Water Act 1945(a)" substitute the words "statutory water undertakers within the meaning of the Water Act 1973(b)".
4. In paragraph 3 of the Schedule—
  - (a) in the definition of "building work" after the words "paragraph 1(i)" insert the words "or (iA)";
  - (b) in the definition of "civil engineering work"—
    - (i) for the words "gas-making plant" substitute the words "gas-making or gas treatment works"
    - (ii) after the words "paragraph 1(i)" insert the words "or (iA)";
  - (c) in the definition of "local authority" for the words "Local Government Act 1933(c)" substitute the words "Local Government Act 1972(d)";
  - (d) for the definition of "pipeline" substitute the following—" 'pipeline' does not include a pneumatic despatch tube;".
5. (a) In the Appendix to the Schedule substitute the following entries for the corresponding entries—

#### EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order further amends the Industrial Training (Engineering Board) Order 1964 (which was amended by the Industrial Training (Engineering Board) Order 1971) which specifies the activities in relation to which the Engineering Industry Training Board exercises its functions.

There will henceforth be included in the activities of the industry the assembly, construction, erection, installation or fitting on site of any of the chemical, electrical or mechanical apparatus, machinery or plant of a chemical works, gas-making or gas treatment works, nuclear or thermal power station, hydro-electric station, oil refinery or oil terminal, metal smelter, steel mill, paper mill or brewery.
