EDUCATION, ENGLAND AND WALES

The Remuneration of Teachers (Primary and Secondary Schools) (Amendment No. 4) Order 1974

Made -12th December 1974 Coming into Operation 13th December 1974

Whereas-

- (1) in pursuance of section 2(2) of the Remuneration of Teachers Act 1965(a) ("the Act") the Committee constituted under section 1 thereof for the purpose of considering the remuneration payable to teachers in primary and secondary schools maintained by local education authorities ("the Committee") have transmitted to the Secretary of State for Education and Science ("the Secretary of State") recommendations agreed on by them with respect to the remuneration of such teachers;
- (2) there are in force Orders made under section 2 of the Act with respect to the remuneration of teachers in primary and secondary schools maintained by local education authorities, namely, the Remuneration of Teachers (Primary and Secondary Schools) Order 1973(b), the Remuneration of Teachers (Primary and Secondary Schools) (Amendment) Order 1974(c), the Remuneration of Teachers (Primary and Secondary Schools) (Amendment No. 2) Order 1974(d) and the Remuneration of Teachers (Primary and Secondary Schools) (Amendment No. 3) Order 1974(e);
- (3) it appears to the Secretary of State that effect can more conveniently be given to the recommendations of the Committee by amending the scales and other provisions set out in the document referred to in the said Orders, namely, the document published by Her Majesty's Stationery Office on 24th May 1973 under the title "Scales of Salaries for Teachers in Primary and Secondary Schools, England and Wales, 1973" ("the Document");
- (4) in pursuance of section 2(5) of the Act the Secretary of State has prepared a draft Order (being the draft of this Order) setting out the amendments of the scales and other provisions which, in his opinion, are requisite for giving effect to the recommendations of the Committee; and
- (5) the Secretary of State, as required by section 2(6) of the Act, has consulted the Committee with respect to the draft Order and the Committee have made no representations with respect thereto.

Now, therefore, the Secretary of State, in pursuance of section 2(6) of the Act, hereby orders as follows:—

Citation and commencement

1. This Order may be cited as the Remuneration of Teachers (Primary and Secondary Schools) (Amendment No. 4) Order 1974 and shall come into operation on 13th December 1974.

Interpretation

2. The Interpretation Act 1889(a) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Amendment of Document

3. The scales and other provisions set out in the Document are hereby amended so as to give effect to the provisions of this Order.

Special salary payment

- 4. A teacher who on 5th December 1974 was employed in a school maintained by a Local Education Authority as a qualified teacher or a teacher to whom section 8(2)(a), 9(a) or 10(a) of the Document applies shall be paid, in addition to any other remuneration payable to him by virtue of the Document—
 - (a) if he was then in full-time service, £100;
 - (b) if he was then in regular part-time service, a proportion of £100 determined in accordance with section 18 of the Document.
