The Rabies (Importation of Dogs, Cats and Other Mammals) Order 1974

Power to destroy imported animals

14.— $[^{F1}(1)]$ An inspector $[^{F2}$ or a constable] may $[^{F3}$ seize or cause to be seized, and thereafter] destroy or cause to be destroyed any animal landed in Great Britain in contravention of this order, or of a licence granted hereunder, or any animal in respect of which there is, after it has been landed, a contravention of any such licence, and the reasonable expenses incurred in the exercise of the power conferred by the foregoing provisions of this paragraph shall, without prejudice to any proceedings arising in connection with a contravention of this order, or of a licence granted hereunder, be recoverable on demand by $[^{F4}$ the Minister, the local authority or, as the case may be, the police authority] as a civil debt from the owner of the animal.

[^{F5}(2) But, where the animal is subject to [^{F6}Article ^{F7}... 10] of the Pets Regulation, paragraph (1) is subject to [^{F8}Article 35(1)(c)] of the Pets Regulation.]
