**The Teachers' Superannuation (Teacher's Contribution)**  
**Regulations 1974**

The Secretary of State for Education and Science, with the consent of the Minister for the Civil Service and after consultation with representatives of local education authorities and of teachers and with such representatives of other persons likely to be affected as appear to him to be appropriate, in exercise of the powers conferred on him by section 9 of the Superannuation Act 1972(a) hereby makes the following regulations:—

*Citation, commencement and interpretation*

**1.**—(1) These regulations may be cited as the Teachers' Superannuation (Teacher's Contribution) Regulations 1974 and shall be included among the regulations which may be cited together as the Teachers' Superannuation Regulations 1967 to 1974.

(2) These regulations shall come into operation on 1st April 1974.

(3) The Interpretation Act 1889(b) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

*Alteration in contributions*

**2.** The Teachers' Superannuation (Financial Provisions) Regulations 1972(c) as amended(d) shall have effect with the substitution—

- (a) in regulation 5(2) (teacher's contribution), for the words "six and three quarters per cent." of the words "six per cent.";
- (b) in regulation 5(3) (employer's contribution), for the words "six and three quarters per cent." of the words "six per cent.";
- and
- (c) in regulation 7A(2) (balance of new entrant contribution), for the words "thirteen and one half per cent." of the words "twelve per cent."
