The National Health Service (Constitution of Regional Health
Authorities) Order 1975

The Secretary of State for Social Services, in exercise of the powers conferred on her by sections 5(1)(a) and 56(3) of the National Health Service Reorganisation Act 1973(a) and of all other powers enabling her in that behalf, hereby makes the following Order:—

Citation, commencement and interpretation

1.—(1) This Order may be cited as the National Health Service (Constitution of Regional Health Authorities) Order 1975 and shall come into operation on 1st August 1975.

(2) In this Order—

“the Act of 1973” means the National Health Service Reorganisation Act 1973;

“Authority” means Regional Health Authority;

“the Determination of Regions Order” means the National Health Service (Determination of Regions) Order 1973(b), as amended (c).

(3) The Interpretation Act 1889(d) applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

Constitution of Authorities

2. There shall continue to be constituted an Authority for each of the regions set out in the Schedule to the Determination of Regions Order and numbered respectively 1 to 14 in that Schedule.

Names of Authorities

3. The Authority for each of the said regions numbered 1 to 14 in the Schedule to the Determination of Regions Order and correspondingly numbered in column (1) of the Schedule hereto shall be known by the name set out in column (2) of the Schedule hereto opposite the number in column (1).

Alteration of name of Region

4. In the Determination of Regions Order for the entry “East Anglia Region” in column (2) opposite No. 4 in column (1) of the Schedule there shall be substituted “East Anglian Region”.
