The Secretary of State for Social Services, in exercise of the powers conferred upon her by section 67(1) of the Social Security Pensions Act 1975<sup>(a)</sup> and of all other powers enabling her in that behalf, hereby makes the following order:—

1. This order may be cited as the Social Security Pensions Act 1975 (Commencement No. 1) Order 1975 and shall come into operation on 7th August 1975.

2. The day appointed for the coming into force of each of the provisions of the Social Security Pensions Act 1975 specified in the Schedule to this Order shall be 7th August 1975.

#### EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order brings into force certain provisions of the Social Security Pensions Act 1975 including provision whereby a person with simultaneous entitlement to more than one pension under the Social Security Act 1975 may choose which pension to receive; the repeal of Part III of the Social Security Act 1973 (the Reserve Pension Scheme); and a number of provisions relating to financial, technical or general matters.
