The Police Cadets (Scotland) Amendment Regulations 1975

Made - - - 30th August 1975
Laid before Parliament 15th September 1975
Coming into Operation 6th October 1975

In exercise of the powers conferred on me by section 27 of the Police (Scotland) Act 1967(a), and of all other powers enabling me in that behalf, and after consulting the Police Council for the United Kingdom in accordance with section 4(4) of the Police Act 1969(b), I hereby make the following regulations:—

Citation

1. These regulations may be cited as the Police Cadets (Scotland) Amendment Regulations 1975.

Operation and Effect

- 2. These regulations shall come into operation on 6th October 1975 and shall have effect:—
 - (a) for the purposes of regulations 6, 7 and 8 on 1st September 1975 and
 - (b) for the purposes of the remaining regulations on 6th October 1975.

Interpretation

- 3. In these regulations any reference to the principal regulations is a reference to the Police Cadets (Scotland) Regulations 1968(c), as amended(d).
- 4. The Interpretation Act 1889(e) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

Amendments

5. For Regulation 6 of the principal regulations (public holidays) there shall be substituted the following regulation:—

"Public holidays

6. A police cadet who, for the purposes of training, is assigned to duties with a constable shall be granted a day's leave on each public holiday, that is to say Christmas Day, New Year's Day and each of 5 other days, being so far as is practicable local public holidays.".

6. For the Table in Schedule I to the principal regulations (pay) there shall be substituted the following table:—

- 7. Regulation 7 of the Police Cadets (Scotland) Amendment Regulations 1974 is hereby revoked.
- 8. In Schedule II to the principal regulations (charge for board and lodging) for the sum of "£135" there shall be substituted the sum of "£165".

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Police Cadets (Scotland) Regulations 1968.

Regulation 5 increases the number of public holidays from 6 to 7 and it designates Christmas Day as the additional day in Scotland.

Regulation 6 provides for increases in pay.

Regulation 7 abolishes threshold payments (which are now consolidated into the new pay scales).

Regulation 8 increases charges for board and lodging.

The provision that regulations 6, 7 and 8 shall have retrospective effect is contained in Regulation 2 (made in exercise of the power conferred by section 27(2) of the Police (Scotland) Act 1967).
