# The Cheese Prices (No. 2) (Second Amendment) Order 1975

27th November 1975 Made -Laid before Parliament 28th November 1975 Coming into Operation 1st December 1975

The Secretary of State, after consulting in accordance with subsection (6) of section 2 of the Prices Act 1974(a) as amended(b) with the organisations therein referred to, in exercise of her powers under subsections (1) and (8) of that section and of all other powers enabling her in that behalf, hereby makes the following Order:-

- 1.—(1) This Order may be cited as the Cheese Prices (No. 2) (Second Amendment) Order 1975 and shall come into operation on 1st December 1975.
- (2) The Interpretation Act 1889(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament, and as if this Order and the Order hereby revoked were Acts of Parliament.
- 2. Article 5 of the Cheese Prices (No. 2) Order 1975(d), as varied (e), is hereby further varied by the substitution for the Table set out in that article of the following Table-
