The Forms of Adoption Entry Regulations 1975

Made - - - - 28th November 1975

Laid before Parliament 5th December 1975

Coming into Operation 1st January 1976

The Registrar General in exercise of the powers conferred on him by sections 21(1) and 56(1) and (2) of the Adoption Act 1958(a) (as amended by paragraphs 24 and 38 of Schedule 3 to the Children Act 1975(b) respectively), section 2(2) of the Welsh Language Act 1967(c) and of all other powers enabling him in that behalf, with the approval of the Secretary of State hereby makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Forms of Adoption Entry Regulations 1975, and shall come into operation on 1st January 1976.

Interpretation

2. The rules for the construction of Acts of Parliament contained in the Interpretation Act 1889(d) shall apply for the purposes of the interpretation of these regulations as they apply for the purposes of the interpretation of an Act of Parliament.

“Wales” means the area consisting of counties established by section 20 of the Local Government Act 1972(e) (new local government areas in Wales), and

“England” does not include any area included in any of those counties.

Form of entry in the Adopted Children Register

3. The entry to be made in the Adopted Children Register pursuant to a direction made by—

(a) a Court sitting in England, shall be in the form set out in Schedule 1 to these regulations;

(b) a Court sitting in Wales, shall be in the form set out in Schedule 2 to these regulations.
