SHERIFF COURT, SCOTLAND

The Sheriff Court Districts Reorganisation Order 1975

Made - - - 14th April 1975

Coming into Operation 16th May 1975

In exercise of the powers conferred on me by sections 3 and 43(2) of the Sheriff Courts (Scotland) Act 1971(a), and of all other powers enabling me in that behalf, I hereby make the following order:—

- 1. This order may be cited as the Sheriff Court Districts Reorganisation Order 1975 and shall come into operation on 16th May 1975.
 - 2.—(1) In this order, unless the context otherwise requires,—
 - "the Act" means the Sheriff Courts (Scotland) Act 1971;
 - "new sheriff court district" means one of the new sheriff court districts specified in the Schedule to this order; and
 - "sheriffdom" means one of the new sheriffdoms specified in article 2 of the Sheriffdoms Reorganisation Order 1974(b).
- (2) In this order any reference to any enactment shall be construed as a reference to that enactment as amended or extended by or under any other enactment.
- (3) The Interpretation Act 1889(c) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.
- 3.—(1) On and after 16th May 1975 each of the sheriffdoms listed in column 1 of the Schedule to this order shall be divided, in place of the sheriff court districts comprised therein immediately before that date, into the new sheriff court districts specified in relation to that sheriffdom in column 2 of the said Schedule, and each of the said new sheriff court districts shall comprise the area described in relation thereto, by reference to the local government areas under the Local Government (Scotland) Act 1973(d), in column 3 of the said Schedule.
- (2) On and after 16th May 1975 sheriff courts shall be held in each new sheriff court district at the place specified in relation to that district in column 4 of the Schedule to this order.
- (3) Sheriff courts shall at 16th May 1975 cease to be held at Dunblane, Hawick, Kinross, Lochgilphead and Wigtown.
- 4. Where immediately before 16th May 1975 a sheriff was required or directed to perform his duties as sheriff in a certain sheriff court district that sheriff shall on and after that date, without the necessity of any new direction being given to him, perform his duties as sheriff in the new sheriff court district in which the place where he previously was required to perform his duties as sheriff is located.

- 5. Where immediately before 16th May 1975 any person held the office of a sheriff clerk depute in any sheriff court district that person shall on and after that date hold the office of a sheriff clerk depute in the new sheriff court district in which the place where he previously was required to perform his duties as sheriff clerk depute is located, as if he had been appointed to that office by the Secretary of State.
- 6. The general jury book kept in any sheriff clerk's office in terms of section 3 of the Jurors (Scotland) Act 1825(a) immediately before 16th May 1975 may on and after that date be used as the general jury book for the new sheriff court district in which that sheriff clerk's office is located and be deemed to satisfy the requirements of the said section 3, notwithstanding that the area in respect of which the said book was kept immediately before 16th May 1975 may not be the area comprised in that new sheriff court district:

Provided that the sheriff principal for the sheriffdom in which the said sheriff court district is contained shall as soon as is reasonably practicable adjust the said book to ensure that it contains the names and designations of persons within the new sheriff court district who are qualified and liable to serve as jurors.

- 7. All procedure in respect of any application for the grant of a certificate of registration or for the renewal of a certificate of registration in respect of any club under section 169 or section 170 of the Licensing (Scotland) Act 1959(b) which on 16th May 1975 has been lodged and is pending shall be conducted by the sheriff clerk with whom the said application was lodged and the sheriff having jurisdiction at the place where the application was lodged, and the said sheriff shall, on granting any such application, cause the required entries to be made in accordance with section 171(5) of the said Act in the register of clubs kept by the sheriff clerk of the new sheriff court district in which the club is located and the sheriff clerk of that district shall thereupon issue a certificate of registration in accordance with the said section 171(5).
- 8. All procedure in respect of any application for the registration or renewal of the registration of any club or miners' welfare institute under Part II or Part III of the Gaming Act 1968(c) which on 16th May 1975 has been made and is pending shall be conducted by the sheriff clerk to whom the said application was made and the sheriff having jurisdiction at the place where the said application was made, and the said sheriff shall, on granting any such application, cause the club or institute to be registered, or the registration thereof to be renewed, in the register kept in terms of Schedule 10 to the Gaming Act 1968 by the sheriff clerk of the new sheriff court district in which the club or institute is located and shall issue the appropriate certificate of registration or of renewal of registration.
- **9.**—(1) Article 3(3) of the Sheriffdoms Reorganisation Order 1974 is hereby revoked.
- (2) Section 38 of the Interpretation Act 1889 shall apply as if this order were an Act of Parliament and as if the order partially revoked by this order were an Act of Parliament partially repealed by an Act of Parliament.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order provides for the division of each of the six sheriffdoms of Scotland into new sheriff court districts as at 16th May 1975 and abolishes the sheriff court districts existing prior to that date (Article 3(1) and Schedule). The boundaries of the new sheriff court districts in most cases correspond to the boundaries of districts and islands areas under the Local Government (Scotland) Act 1973. The Order also specifies the places where sheriff courts are to be held in each new sheriff court district (Article 3(2) and Schedule) and provides that sheriff courts shall cease to be held at Dunblane, Hawick, Kinross, Lochgilphead and Wigtown (Article 3(3)).

The remaining provisions of the Order are transitional and consequential.
