## The Deputy Lieutenants (Scotland) Reallocation Order 1975

Made - - - - 21st April 1975

Coming into Operation 16th May 1975

In exercise of the powers conferred on me by section 205 of the Local Government (Scotland) Act 1973(a) and of all other powers enabling me in that behalf I hereby make the following Order:

1. This Order may be cited as the Deputy Lieutenants (Scotland) Reallocation Order 1975 and shall come into operation on 16th May 1975.

2. The Interpretation Act 1889(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

3. As from 16th May 1975 each of the persons specified in column 1 of the Schedule to this Order, being a person who immediately before 16th May 1975 was holding office as a Deputy Lieutenant, shall continue on and after that date to hold office as a Deputy Lieutenant in that district of the city or part of the region specified in column 2 of the said Schedule.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

Section 205(8) of the Local Government (Scotland) Act 1973 provides that any Deputy Lieutenant holding office immediately before 16th May 1975 shall continue to hold office on and after that date as Deputy Lieutenant of the part of the region, islands area or district of the city in which he resides or of such other area as may be specified in an Order made by the Secretary of State. The Order herein specifies Deputy Lieutenants whose continuation in office shall be exercised with effect from the 16th May 1975 in relation to a new area and as specified in the Order.
