CUSTOMS AND EXCISE

**The Import Duties (Turkey) (Reductions and Exemptions)
(Amendment) Order 1975**

Made - - - - - 23rd January 1975

Laid before the House of Commons 7th February 1975

Coming into Operation 1st March 1975

The Lords Commissioners of Her Majesty's Treasury, by virtue of the powers conferred on them by sections 1, 3(6) and 13 of the Import Duties Act 1958(a), as amended(b), and of all other powers enabling them in that behalf, on the recommendation of the Secretary of State(c), hereby make the following Order:

1.— (1) This Order may be cited as the Import Duties (Turkey) (Reductions and Exemptions) (Amendment) Order 1975 and shall come into operation on 1st March 1975.

(2) The Interpretation Act 1889(d) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

(3) This Order does not increase duties of customs otherwise than in pursuance of a Community obligation.

2. Schedule 3 to the Import Duties (Turkey) (Reductions and Exemptions) Order 1974(e) shall be amended as specified in the Schedule hereto.

AMENDMENTS TO SCHEDULE 3 TO THE IMPORT DUTIES (TURKEY) (REDUCTIONS AND EXEMPTIONS) ORDER 1974

1. In column 3 of subheading 08.02 A.II.b)1.aa), for "4.3%" there shall be substituted "4.8%".
 2. In column 1 of subheading 08.02 B.I.a), "1." and "2." shall be deleted and in column 3, for "£0-0630" there shall be substituted "£0-0525" and "5.5%" shall be deleted.
 3. In column 1 of subheading 08.12 A., for "I" there shall be substituted "II".
 4. In column 3 of subheading 58.01 A.II.b), for "9.5%" there shall be substituted "7.5%".
