**The Import Duties (Turkey) (Reductions and Exemptions)
 (Amendment) Order 1976**

Made - - - - 2nd December 1976

*Laid before the House
 of Commons - - 10th December 1976*

Coming into Operation 1st January 1977

The Lords Commissioners of Her Majesty's Treasury, by virtue of the powers conferred on them by sections 1, 3(6) and 13 of the Import Duties Act 1958(a), as amended by section 5(5) of, and paragraph 1 of Schedule 4 to, the European Communities Act 1972(b), and of all other powers enabling them in that behalf, on the recommendation of the Secretary of State(c), hereby make the following Order:—

1.—(1) This Order may be cited as the Import Duties (Turkey) (Reductions and Exemptions) (Amendment) Order 1976 and shall come into operation on 1st January 1977.

(2) The Interpretation Act 1889(d) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

(3) This Order does not increase duties of customs otherwise than in pursuance of a Community obligation.

2. The Import Duties (Turkey) (Reductions and Exemptions) Order 1975(e) shall be amended as specified in the Schedule hereto.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, which comes into operation on 1st January 1977, amends the Import Duties (Turkey) (Reductions and Exemptions) Order 1975, by transferring certain horticultural products from the provisions of Schedule 2 to Schedule 3 to that Order and altering the rate of import duty on certain horticultural products and other goods in Schedule 3 thereto. The amendments are made in accordance with the United Kingdom's Community obligations, concerning import duties after the end of 1976, in respect of goods of Turkey.
