CUSTOMS AND EXCISE

The Customs Duties (E.C.S.C.) (Amendment) Order 1977

<i>Made - - - -</i>	<i>4th July 1977</i>

<i>Coming into Operation</i>	<i>6th July 1977</i>

The Treasury, by virtue of the powers conferred on them by section 5(1) and (3) of the European Communities Act 1972(a) and of all other powers enabling them in that behalf, on the recommendation of the Secretary of State, hereby make the following Order:—

1.—(1) This Order may be cited as the Customs Duties (E.C.S.C.) (Amendment) Order 1977 and shall come into operation on 6th July 1977.

(2) The Interpretation Act 1889(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

2. The Customs Duties (E.C.S.C.) Order 1977(c) shall be amended as follows:—

(1) In Part I of Schedule 1 there shall be inserted the following countries namely Algeria, Egypt, Israel, Jordan, Lebanon, Morocco, Syria and Tunisia.

(2) In Schedule 2 there shall be inserted—

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, which comes into operation on 6th July 1977, amends the Customs Duties (E.C.S.C.) Order 1977, which provides for the ECSC unified tariff and the customs duties chargeable in accordance with it.

This Order provides for exemption from those duties in the case of goods of Algeria, Egypt, Israel, Jordan, Lebanon, Morocco, Syria and Tunisia in accordance with Decisions of Representatives of the Governments of the member States of the ECSC meeting within the Council.
