The Police Cadets (Scotland) Amendment Regulations 1977

<i>Made - - - -</i>	<i>4th July 1977</i>

In exercise of the powers conferred on me by section 27 of the Police (Scotland) Act 1967(a), and of all other powers enabling me in that behalf, and after consulting the Police Council for the United Kingdom in accordance with section 4(4) of the Police Act 1969(b), I hereby make the following regulations.

Citation

1. These regulations may be cited as the Police Cadets (Scotland) Amendment Regulations 1977.

Interpretation

2. In these regulations any reference to the principal regulations is a reference to the Police Cadets (Scotland) Regulations 1968(c), as amended(d).

3. The Interpretation Act 1889(e) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

Operation and effect

4. These regulations shall come into operation on 5th August 1977 and shall have effect—

- (a) for the purposes of regulation 5 as from 1st April 1976;
- (b) for the purposes of regulation 6 as from 1st September 1976;
- (c) for the purposes of regulation 7 as from 5th August 1977.

Uniform and equipment

5. In regulation 16 (1A) of the principal regulations (which relates to uniform and equipment), for the sum “£0.290” there shall be substituted the sum “£0.350”.

Pay

6. For the Table in Schedule 1 to the principal regulations (which contains scales of pay) there shall be substituted the following Table:—

“TABLE

Age	Annual Pay
Under 17 years	£1,248
17 years	£1,323
18 years	£1,474
19 years	£1,510”

Charges for board and lodging

7. In Schedule 2 to the principal regulations (which relates to charges for board and lodging), for the sum “£165” there shall be substituted the sum “£180”.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Police Cadets (Scotland) Regulations 1968.

Regulation 5 provides for an increase in footwear allowance from 29p to 35p a week.

Regulation 6 provides for increases in annual pay.

Regulation 7 provides for an increase in charges for board and lodging from £165 to £180.

Provision that Regulations 5 and 6 shall have retrospective effect is contained in Regulation 4 (made in exercise of the power conferred by section 27(2) of the Police (Scotland) Act 1967).
