The Secretary of State, in exercise of powers conferred by section 8 of the Civil Aviation Act 1968(a), and now vested in him(b), and of all other powers enabling him in that behalf, hereby makes the following Order:

1. This Order may be cited as the Aerodromes (Designation) (Facilities for Consultation) Order 1977 and shall come into operation on 15th August 1977.
2. The Interpretation Act 1889(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if this Order and the Orders hereby revoked were Acts of Parliament.
3. The aerodromes specified in Schedule 1 hereto, being aerodromes managed by persons other than the British Airports Authority, are hereby designated for the purpose of section 8 of the Civil Aviation Act 1968.
4. The Orders specified in Schedule 2 hereto are hereby revoked.
