POLICE

The Police (Scotland) Amendment (No. 2) Regulations 1977

Made - - - - 2nd December 1977

Laid before Parliament 15th December 1977

Coming into Operation 16th December 1977

In exercise of the powers conferred on me by section 26 of the Police (Scotland) Act 1967(a), and of all other powers enabling me in that behalf, and after consulting the Police Council for the United Kingdom in accordance with section 4(4) of the Police Act 1969(b), I hereby make the following regulations:—

PART I

Citation, commencement, operation and interpretation.

1. These regulations may be cited as the Police (Scotland) Amendment (No. 2) Regulations 1977.
2. These regulations shall come into operation on 16th December 1977 and shall have effect for the purposes of Part II thereof as from 1st September 1977.
3. In these regulations any reference to the principal regulations is a reference to the Police (Scotland) Regulations 1976(c), as amended(d).
4. The Interpretation Act 1889(e) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

PART II

Provisions having effect from 1st September 1977

5. In Regulation 51(2) of the principal Regulations (detective duty allowance), for the annual rate “£471” there shall be substituted the annual rate “£518”.
6. In Regulation 59(1) of the principal Regulations (special area undermanning allowance), for the annual rates “£30”, “£45” and “£65” there shall be substituted the annual rates “£33”, “£50” and “£72” respectively.

7. In Schedule 3 to the principal regulations—
- (a) in Part I (scales of pay), for the Tables designated A and B there shall be substituted, respectively, the Tables so designated and set out in Part I of the Schedule to these regulations;
 - (b) in Part II (supplementary pay) for the Table designated C there shall be substituted the Table so designated and set out in Part II of the Schedule to these regulations.
8. In paragraph 1(1) of Schedule 10 to the principal Regulations (dog handler's allowance), for the annual rates "£231" and "£309" there shall be substituted, respectively, the annual rates "£254" and "£340".
9. Regulation 5 of the Police (Scotland) Amendment Regulations 1977(a) (increased pay) is hereby revoked.
