The Minister of Agriculture, Fisheries and Food and the Secretaries of State concerned with sea fishing in Scotland and Northern Ireland respectively, in exercise of the powers conferred on them by sections 2(1) and 6(2) of the Fishery Limits Act 1976(a) and of all other powers enabling them in that behalf, hereby make the following order:—

Citation and commencement

1. This order may be cited as the Fishing Boats (Specified Countries) Designation (No. 3) (Variation) (No. 4) Order 1977 and shall come into operation on 16th December 1977.

Interpretation

2.—(1) In this order “principal order” means the Fishing Boats (Specified Countries) Designation (No. 3) Order 1977(b) as amended(c).

(2) The Interpretation Act 1889(d) shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament.
