## **ROAD TRAFFIC**

# The Removal and Disposal of Vehicles (Amendment) Regulations 1977

Made - - - 1st March 1977

Laid before Parliament 10th March 1977

Coming into Operation 31st March 1977

The Secretary of State for Transport (as respects England), the Secretary of State for Scotland (as respects Scotland) and the Secretary of State for Wales (as respects Wales), in exercise of the powers conferred by sections 21(4) and 22(1) of the Civic Amenities Act 1967(a) and sections 52(1) and 53(3) of the Road Traffic Regulation Act 1967(b), as altered by the Removal and Disposal of Vehicles (Alteration of Enactments) Order 1967(c), and now vested in them(d), and of all other enabling powers, and after consultation with representative organisations in accordance with the provisions of section 107(2) of the Road Traffic Regulation Act 1967, hereby make the following Regulations:—

- 1. These Regulations may be cited as the Removal and Disposal of Vehicles (Amendment) Regulations 1977 and shall come into operation on 31st March 1977.
- 2. The Removal and Disposal of Vehicles Regulations 1968(e), as amended by the Removal and Disposal of Vehicles (Amendment) Regulations 1974(f) and the Removal and Disposal of Vehicles (Amendment) Regulations 1975(g) (which Regulations of 1968, as so amended, are hereinafter referred to as "the 1968 Regulations") shall be further amended in accordance with Regulation 3 below.
- 3. In Regulation 17(1) (Charge for removing vehicles) of the 1968 Regulations
  - in sub-paragraph (a) (removals from motorways) for the words "£18" there shall be substituted the words "£22";
  - in sub-paragraph (b)(i) (other removals in London) for the words "£15" there shall be substituted the words "£20";

## **EXPLANATORY NOTE**

(This Note is not part of the Regulations.)

These Regulations increase certain of the charges payable under the Removal and Disposal of Vehicles Regulations 1968 (as amended).

The charge for removing a vehicle from a motorway is increased from £18 to £22. The charge for removing a vehicle from a place not on a motorway is increased from £15 to £20 for removals in London and from £14 to £18 for removals elsewhere.
