The Sheriffs' Fees (Amendment) Order 1977

Made - - - - - 3rd March 1977

Coming into Operation 15th April 1977

The Lord Chancellor, in exercise of the powers conferred on him by section 20(2) of the Sheriffs Act 1887(a), with the advice and consent of the Judges of the Court of Appeal and the High Court, and with the concurrence of the Treasury, hereby makes the following Order:—

1.—(1) This Order may be cited as the Sheriffs' Fees (Amendment) Order 1977 and shall come into operation on 15th April 1977.

(2) In this Order—

“the Order of 1920” means the Order made under section 20(2) of the Sheriffs Act 1887 and dated 8th July 1920(b), as amended (c);

“the Order of 1921” means the Order made under the said section 20(2) and dated 2nd May 1921(d), as amended (e).

(3) The Interpretation Act 1889(f) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

2. In Fee No. 1 in the Table of Fees set out in the Schedule to the Order of 1920, for the figure “£0·08” there shall be substituted the figure “£0·10”.

3. In Fee No. 7A in the Table of Fees set out in Part 1 of the Schedule to the Order of 1921 for the figure “£0·05” there shall be substituted the figure “£0·10”.
