# **RATING AND VALUATION**

# The Assessor of Public Undertakings Valuations (Procedure Dates and Time Limits) (Scotland) Amendment Order 1978

Made - - - 28th September 1978

Coming into Operation 29th September 1978

In exercise of the powers conferred on me by section 5 of the Rating and Valuation (Scotland) Act 1952(a), section 13(1) of the Valuation and Rating (Scotland) Act 1956(b), as read with section 22(d) of the Local Government (Financial Provisions) (Scotland) Act 1963(c) and as amended by paragraph 20 of Schedule 6 to the Local Government (Scotland) Act 1975(d), section 42(1) of the said Act of 1956 and of all other powers enabling me in that behalf, I hereby make the following order:—

### Citation and commencement

1. This order may be cited as the Assessor of Public Undertakings Valuations (Procedure Dates and Time Limits) (Scotland) Amendment Order 1978 and shall come into operation on 29th September 1978.

#### Interpretation

- 2.—(1) The Interpretation Act 1889(e) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.
- (2) In this order "the principal order" means the Assessor of Public Undertakings Valuations (Procedure Dates and Time Limits) (Scotland) Order 1975(f).

## Amendment of principal order

- 3. The principal order shall be varied as follows:—
  - (a) In article 2(2) the definition of "gas valuation" shall be deleted.
  - (b) In article 4 the words ", not being a gas valuation," and "other than gas valuations" shall be omitted.

(c) In Part I of the Schedule, for the first entry in Column 2 there shall be substituted the following entry— "As respects the year 1979-80, 1st October; as respects any subsequent year not being a year of revaluation, 1st September.".

#### Revocation

4. The Assessor of Public Undertakings Valuation Roll (Procedure Dates) (Gas Boards) (Scotland) Order 1957(a) is hereby revoked.

#### **EXPLANATORY NOTE**

(This Note is not part of the Order.)

This Order amends the provisions of the Assessor of Public Undertakings Valuations (Procedure Dates and Time Limits) (Scotland) Order 1975 by extending the timetable for formula valuations which that Order prescribed to include the formula valuation of certain lands and heritages occupied by the British Gas Corporation, and by amending, with effect from 1st September 1979, the last date for attendance before, or for the giving of statements or production of documents to, the Assessor of Public Undertakings (Scotland).

The Order also revokes the Assessor of Public Undertakings Valuation Roll (Procedure Dates) (Gas Boards) (Scotland) Order 1957, which prescribed certain dates which are no longer appropriate.
